Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

HCOE Court/Community School gained feedback from stakeholders which included parents, teachers, school staff, and students. Feedback was elicited in multiple ways including: surveys, stakeholder input meetings, and staff meetings. The feedback provided a framework for the development of the plan. Feedback that was provided highlighted the greatest needs which include: additional support for credit deficient students to complete graduation requirements, additional academic support services for students, transportation for after school expanded learning opportunities, additional assessment tools to measure learning loss, and after school enrichment programs to support credit recovery. The Expanded Learning Opportunities Grant Plan will be presented at the HCOE Board of Trustees meeting in May 2021 for adoption.

A description of how students will be identified and the needs of students will be assessed.

The district will utilize multiple measures to identify and assess the needs of students. Our district has four school sites; however, our overall population is very small. All student transcripts will be reviewed by their teacher to identify credit recovery plans and individual learning plans. Upon enrollment each student and parent will receive an outline of coursework that will need to be completed to recover credits and progress towards graduation requirements. The extended learning opportunities will be presented and students will sign up the appropriate courses. The district will utilize multiple assessments to identify student's academic needs. The TABE test will be utilized to determine grade level equivalency in ELA and Math. The district will also utilize I-Ready, which is a customizable assessment program to measure student proficiency and growth. The assessment tool will allow the district to measure student progress and supplement curriculum to support areas of concern. Special education students will receive support through the IEP process to determine additional supports and services. The

ELPAC Coordinator will review current ELPAC scores and determine academic supports needed. The district has implemented MTSS and meets weekly to review students referred to Tier II Services. Students are referred and reviewed to determine which Tier II supports would be beneficial. The Tier II supports include academic and social/emotional support services.

The district serves at-risk students who typically are academically behind one or more semester with a population of 89% low income students and 38% McKinney Vento students. Our student population has a high percentage of low-income students so all efforts are LEA wide.

The adopted Expanded Learning Grant Plan will be posted on the CCS website and will be shared at future stakeholder meetings, family nights, and the School Site Council meetings. Families and students will also be given information on programs and support services available upon initial enrollment for the 21-22 school year. Translated materials for parents will be available for our Spanish speaking families. The related services available will also be communicated by staff to students. As new students are enrolled they will receive the information for expanded learning opportunities. Information of offerings will also be presented at IEP meetings, 504 meetings, Student Study Team meetings, and SART meetings.

A description of the LEA's plan to provide supplemental instruction and support.

HCOE Court/Community Schools intends to offer more credit recovery coursework, targeted intervention groups in ELA and Math, skills recoupment groups, after school enrichment and credit recovery opportunities, and additional transportation to the supplemental programs. The schedule will include intervention time in order to have focused remediation services for students based on their individual learning plan and need. English Learners will receive supplemental English Language Development support from a paraprofessional to support individual needs as assessed by the most recent ELPAC Test. The district intends to hire temporary staff, a teacher and two additional instructional aides to support the targeted group interventions. After the first semester school staff will review student's individual progress and progression through assessment results and grade cards. Data will be reviewed to determine students that need additional support and will continue to receive additional targeted interventions.

The district will also provide more social/emotional and mental health support. The district intends to provide group and individual school based counseling. CCS will utilize more school psychologist support and a behavioral clinician through SELPA to meet the needs of our students.

CCS will focus on multiple areas of support for our students to provide integrated pupil supports such as mental health services, access to school meal programs, after school programs, and professional development and programs to address trauma.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

HCOE Court/Community District is coordinating the use of the Expanded Learning Grant (ELG) and other Federal ESSER funds by budgeting all funding sources across several categories to best meet the needs of our district, students, staff, and community. The ELG funds are primarily budgeted towards integrated student services such as credit recovery courses, diagnostic assessments, skills recoupment groups, targeted interventions, progress monitoring, additional teaching and paraprofessional staffing. The ESSER funds are planned to be budgeted towards COVID-19 testing costs, PPE, and other sanitation supplies for health and safety efforts.

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
