





In 2022-23, Fortuna Elementary School District is projecting it will receive \$3,137,896 based on the enrollment of foster youth, English learner, and low-income students. California's 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. A significant amount of discussion has taken place at recent board meetings throughout the fall and and winter--especially in the development of the district's ESSER III plan--to determine how to expend the bulk of funds that were not included in the original 2021-22 LCAP. Surveys were sent to teachers who then compiled results and provided those results to board members at a public meeting. Parent and and general public input was gathered at several consecutive board meetings, and ongoing discussions have taken place among school site council members at our district's schools, among employee groups, and at regular monthly staff meetings. Among all discussions, there have been a few commonalities that have repeatedly come to the forefront in most all discussions: keep classes sizes low by the hiring of additional teaching staff, continue to provide funds for professional development opportunities for both certificated and classified staff, increase the number of intervention teachers at all school sites, continue to purchase necessary PPE to help maintain school safety, and help address the social/emotional needs of our students by employing full-time counselors at all district sites.

A description of how the LEA used, or plans to use, the additional concentration grant add-on funding it received to increase the number of staff who provide direct services to students on school campuses with an enrollment of students who are low-income, English learners, and/or foster youth that is greater than 55 percent.

With the inclusion of the additional concentration grant add-on funding, the district added (or intends to add) an additional intervention teacher at each school site which has allowed (or will provide) two full-time intervention teachers at each of the district's four school sites. Each school site will have the ability to have one intervention teacher focus on ELA intervention and the other teacher focus on math intervention. By having two intervention teachers at each site, the district is hoping to provide increased direct services to the majority of all unduplicated

students at every school site.

A description of how and when the LEA engaged its educational partners on the use of one-time federal funds received that are intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on pupils.

From the beginning of the pandemic, the district surveyed parents/guardians and employee groups on how best to meet the academic and social/emotional needs of students. Initially, it was determined that distance learning was necessary for all students, but in the fall of the 20-21 school year, the district soon went back to in-person instruction after putting into place strict health and safety protocols. Prior to the return to in-person instruction, teachers were offered intensive professional development opportunities to assist them in meeting the academic needs and learning how to successfully facilitate distance learning for all students. The district has maintained ongoing opportunities for teachers to continue accessing PD of their choice for continued enhancement of their teaching skills. The district also committed to hiring counselors for all school sites to help mitigate the social/emotional needs of students that have become extremely evident since their return to the school sites. The district's educational partners have also been more engaged by the inclusion of an enhanced communication system that can easily contact parents simultaneously via phone, email, and text at the touch of a button and is just as easy for them to respond back to their respective school sites. In response to those families who are still nervous to send their students to school in person, the district is offering a long-term independent student program where students receive daily live interactive instruction by a dedicated teacher who meets with families and students on a weekly basis to review progress on assignments, and review overall successes and/or areas or need.

The district is basically using the funds to help keep our schools open during a world-wide pandemic. We have hired additional teaching staff and would hire more (classified) if we could find additional employees who would be willing to work. We have spent many thousands of dollars purchasing PPE materials in order to keep our staff and students as safe as possible at the school sites and to help keep our schools as clean and sanitized as possible. HEPA air filtration systems were purchased for every classroom and all office spaces, and students were trained on how to maintain social distancing and wear facial coverings at all times while on their school campuses. When COVID testing became available to schools, we began modified quarantines of students where practicable, regularly tested staff and students to try and keep as many non-positive cases on the school sites as possible without having to unnecessarily quarantine those who had not been overly exposed. We regularly test non-vaccinated employees and we test all athletes twice weekly during their sports seasons. We have also purchased supplemental curricular materials to help support the learning loss experienced by many of our students. Without a doubt, this has arguably been the most challenging event any educator has ever experienced in the education profession. The Fortuna Elementary School District strictly adheres to the established guidelines and expenditure timelines provided by the state and federal government that describe how the additional fiscal resources can be expended. Previously established and board approved expenditures outlined in the district's 2021-22 LCAP are continuing to be used just as they were originally intended to be spent for the benefit of the district's students. FESD has continued to follow the established guidelines and spending plans in its Safe Return to In-Person Instruction, Continuity of Services, and ESSER III Expenditure Plans as well.

## Plan Summary [2022-23]

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Fortuna Elementary School District (FESD) is located within the city of Fortuna in Humboldt County. It serves students in grades TK-8 who reside within the city limits of Fortuna as well as in a few adjacent unincorporated areas that border the city. The district is comprised of four schools: two elementary schools (Ambrosini Elementary and Walker Elementary), that serve students in grades TK-4, and two middle schools (Fortuna Middle School and Toddy Thomas Middle School), that serve students in grades 5-8. Beginning in the fall of 2022, the grade levels at the district's two middle schools will be reconfigured as follows: Toddy Thomas will serve the entire district's population of 5th and 6th graders and Fortuna Middle will serve the entire district's population of 7th and 8th graders. Currently, there is a total enrollment of approximately 1,140 students who are served by one superintendent, four site principals, 85 certificated staff members, and 120 classified staff members. The district maintains mild/moderate Special Day Classes at each school that reflects the grade levels of the school as well as one 5-8 mod/severe Special Day Class located at Toddy Thomas Middle School. Both middle schools facilitate GATE programs for students in grades TK-8. FESD's unduplicated pupil count stands at approximately 78%. Districtwide, 79% of students qualify for the free/reduced meal program and 16% of the student population are designated as English Learners. Race/ethnicity statistics districtwide are as follows: White--51%, Hispanic/Latino--36%, Multiracial--8%, and American Indian/Alaska Native--4%. The Fortuna community is located in coastal Humboldt County in the heart of the redwoods. Fortuna is known as "The Friendly City" and has a population of approximately 12,000 residents.

## **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Even in the midst of the COVID-19 pandemic, the Fortuna Elementary School District opened its doors for full day in-person instruction in August 2021 and has remained open for in-person instruction throughout this entire school year. For those families who still felt uncomfortable sending their students to school, the district offered a long-term independent study program that was facilitated by one of the district's certificated staff members. That program has operated very successfully since the first month of school and on average, has maintained an enrollment of 20-25 students throughout most of the school year. Because of the fact that we continued to deliver in-person instruction, there was not a great deal of student loss of learning throughout the pandemic as measured by local assessment data (Renaissance Learning's STAR ELA and STAR math) as was initially anticipated. Services for our English Learners were also maintained at levels similar to what took place prior to the pandemic. All district staff continued to participate in professional development opportunities mainly through an online platform that was instituted in the prior school year. This particular program called Simple K-12, provides PD opportunities on a vast array of subject areas that allows teachers and paraprofessionals to pick and choose the types of PD experiences they feel are best suited for them. In collaboration with the Humboldt-Del Norte Special Education Local Planning Area (SELPA), the district successfully implemented the actions and goals intended to support students with special needs from its Performance Indicator Review (PIR) plan now referred to as the Special Education Plan (SEP) and is now only needing to verify that all IEP meetings are happening within established timeframes and that no meetings become overdue or go past meeting date deadlines. In what was previously identified as an area of need, the district has now successfully worked to increase the percentage of time students identified with disabilities are active within the general education program.

## **Reflections: Identified Need**

There is still great concern regarding the behavioral needs and social-emotional growth and development of many of the district's students. Classroom and school wide discipline issues in general have increased with many situations of undesired student behaviors dominating dayto-day interactions among peers and with staff members. District wide, there has been an overall increase in the number of student suspensions, especially at the middle schools. District schools have continued with their implementation of PBIS practices and alternative practices to avoid suspending students whenever feasible, as well as attempting alternative means of correction prior to having to ever suspend a student. Both math and ELA performance at all schools needs to be improved, Efforts to continue to increase student performance will be put in place. In math district-wide, SWDs, homeless, and Hispanic student groups are performing at a low level. Efforts to provide additional supports for these student groups are planned for 2021-24 such as added math instructional opportunities, math intervention programs, the addition of math intervention teachers at each school site, and an increase in small group instruction due to added personnel which has helped to lower average class size. Lower performance in ELA for Hispanics and students with disabilities will continue to be addressed through actions included in Goal 1.

## **LCAP Highlights**

The FESD LCAP continues to highlight effective instructional practices and standards-aligned curricular materials in the core content areas for all student groups. Other priorities will be the implementation of appropriate interventions for students in need, the continuation of PBIS practices incorporated into our school climate goals for all schools, an intensified focus of restorative practices--especially at the middle school level, and the continued encouragement of parents and community members to become more involved in our schools. All actions have been aligned to site-level SPSA goals. Ongoing monitoring of goals and actions takes place throughout the course of each school year. The district will continue to implement the stakeholder's preference for providing in-person instruction for all students in all grades, providing counselors at all school sites, recruitment of highly qualified teachers, continued focus on meeting the needs of our unduplicated students, devote additional resources toward after school tutoring opportunities, and in maintaining small class sizes. Health and safety practices and enhanced cleaning and disinfecting of facilities, enacted at the beginning of the pandemic, will continue and the district will also continue to follow county and California department of public health guidelines regarding maintaining safe and effective in person instruction. Overall, the district's plan appears to be working well and stakeholders have suggested to mainly continue with the plan as it was previously written for 2021-22 and carryover the main components into the 2022-23 school year as well.

## **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Our district's four schools hold monthly LCAP Stakeholder meetings in conjunction with monthly Site Council meetings. Each school's Site Council has also taken on the role of the schools' English Language Advisory Committees (ELACs) which are comprised of parents of Spanish-speaking students. Bargaining units, both certificated and classified, are included in LCAP stakeholder meetings and are offered the opportunity to directly provide input into the development of the district's LCAP. Student input related to Goal 3 was collected through the annual School Site Council surveys and was considered when metrics and actions were developed. The public is provided a 72-hour notice prior to the stakeholder meeting dates so that other parents/community members who are not necessarily members of School Site Councils still have the opportunity to provide input on the district's LCAP. SSC/Stakeholder members include administrators, certificated and classified staff, parents/guardians, and community members. In addition to the schools' monthly stakeholder meetings, the district reviews and discusses LCAP at a minimum of 3 board meetings per year. Board meeting agendas are also posted 72 hours prior to any scheduled meeting (in both English and Spanish) to allow any interested community members or parents an opportunity to comment or offer suggestions for the LCAP. It should be noted that due to COVID-19, some stakeholder meetings were still conducted through a virtual format this school year which in some cases, allowed for added participation from stakeholders who have not typically been actively involved in the past. But, on the other hand, there have been some meetings where stakeholder participation has been less than in past years as some participants are not as comfortable, or do not prefer to attend meetings through a virtual format. The following is a detailed list of stakeholder meetings: Ambrosini Elem.: 10/27/21, 12/8/21, 1/19/22, 3/2/22. Walker Elem.: 10/4/21, 1/31/22, 2/28/22, 4/25/22. Fortuna Middle School: 10/28/21, 12/14/21, 1/18/22, 2/16/22, 4/6/22. Toddy Thomas Middle School: 10/27/21, 11/4/21, 1/5/22, 2/2/22, 3/2/22, 4/5/22.

A summary of the feedback provided by specific educational partners.

LCAP Stakeholders are still very supportive of maintaining small class sizes for all elementary and middle schools in the district. There is also continued discussions of maintaining and increasing RTI services at all schools--especially at the middle schools. Stakeholders indicated a need to add another Special Day Class to our district to help support the increasing population of special education students and to accommodate the future changes in grade levels at the two middle schools. It was also noted that additional staff might need to be hired to staff overcrowded SDCs. Stakeholders are appreciative of the district wide use of the Parent Square informative distribution platform and would like to see increased and improved information through all schools' social media platforms and improved maintenance and updating of the districts' websites. As is typical each year, stakeholders indicated they would like to see current district counselors maintained with the addition of full-time counselors at all schools throughout the district. They would also like to see an ongoing budget in the LCAP for technology repair and upgrades, including replacement for broken Chromebooks. Stakeholders were pleased to know that the district's technology plan is currently being revised and updated. They would like to maintain 1:1 devices for all students in grades TK through 8. Stakeholders would also like to see alternatives to suspension (other means of correction) implemented at all district schools. They would like to see additional resources and materials added to address student academic intervention. Stakeholders appreciate the welcome feeling they receive from principals and hope that will facilitate even more parent involvement in the schools. As noted from past years, there are quite a few similarities of the types of feedback that are provided by our district's stakeholders.

The average distance to standard is currently reported at yellow status on the CA Dashboard. The District average is 21.2 points below level 3 in E/LA and is 65 points below level 3 in math.

There were some substantive differences in planned actions and actual implementation of actions within the following specific Actions: 1.3 (Instructional Materials and Replacement of Consumables), 1.6 (Purchase of Technology Devices), 1.7 (Instructional Assistants), 1.12 (Summer School Program), and 1.13 (After School Programs).

1.3: Instructional Materials: There were unplanned purchases of new science and EL materials and additional ELA materials purchased for grades 3-6 (+ \$47,701.00). 1.6: Technology Devices: In addition to the regular annual replacement of Chromebooks using LCFF funds, the district used one-time COVID funds to replace staff computers, classroom Promethean boards, and Chromebooks for board members (+ \$47,934.00). 1.7: Instructional Assistants: The district used one-time COVID funds to add additional paid hours for classified staff, there were salary increases added after budget adoption, and one-time COVID funds were also used to pay a stipend to all classified staff (+ \$83,986.00). 1.12: Summer School Program: As the district had not facilitated a summer program for several years, it inadvertently over-budgeted anticipated costs of the program (- 121,271.00). 1.13: After School Program: The program's grant was increased after budget adoption and there was a significant amount of carryover from the prior year (+ \$69,194).

All but one of the maintenance metrics were met (1.1). Data for metrics 1.3 and 1.4 are incomplete due to the Dashboard information not being available. Data for metric 1.12 is provided in Local Indicator #2.

In 2019, math scores for ELs were 79.6 below standard, Hispanic students were 75.1 below, SED students were 64.9 below, SWDs were 96.2 below standard, and white students were 40.8 below. These results indicated a need for additional support and intervention to address these student needs.

The district's PD committee will be reconvened and teachers will be surveyed as was the practice in past years in order to determine teacher input for needed or preferred PD opportunities. There will also be increased PLC work done among all grade levels to review student progress on a more regular basis to help determine areas of students' greatest academic need that might be addressed through additional PD opportunities for staff members.

2.2: EL, Foster/Homeless, Reading Intervention Staffing: At LCAP adoption, statutory benefits for all certificated staff funded through general fund dollars were inadvertently added to this category resulting in an overstatement of \$668,735. 2.4: EL Supports: The district increased the supplies budget by \$8,240. In addition, one of the district's Interpreter/Translators elected to take H/W benefits which resulted in increased costs to the district of \$11,327.

In reviewing all nine of the metrics in goal 2, it was noted that four of the metrics were met, three were not met, and data is not available for two of the metrics. The metrics that were not met are related to academic achievement. The two metrics that did not have data available also relate to academic achievement. The four metrics that were met are evidence that the actions are making progress toward those goals.

The effects of the pandemic have had more of an effect on student achievement than were originally anticipated. Metric 4.6 showed a slight decline in parents' feelings about the school climate at their child's school. This is likely attributed to the fact that

for almost two years, parents have not been permitted to volunteer or come onto school campuses due to COVID restrictions. Now that those restrictions have been lifted, it is hoped that parents will once again feel welcomed and know that they are valued partners with their children's schools.

#### **Required Descriptions**

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

All students identified as socio-economically disadvantaged, English Learners, and those who are identified as foster/homeless but are not making sufficient progress on local assessments are provided additional academic support in both language arts and math. With the hiring of additional staff through the use of ESSER funds, smaller student-teacher ratios have resulted in more individualized attention for students, enabling teachers to target support daily to specific skills they observe which are a struggle for low-performing students to master. This strategy was particularly rated as of high value by stakeholders who wished to see it continue. The majority of students identified within the various categories of the district's unduplicated student count who continue to perform below standard in English/Language Arts benefit from additional opportunities for students whose families of origin might not be able to provide enhanced opportunities for exposure to literature due to a lack of resources. Unduplicated students living in poverty or who come from homes with very limited resources often lack exposure to technological devices (i.e., computers, laptops, iPads, Chromebooks, cell phones, basic internet connectivity, etc.) and benefit from the use of, and gain academic support, by accessing 1:1 devices that support classroom academic activities and programs. By providing internet access and 1:1 devices, students gain valuable exposure to modern technology and its uses that enhance the overall academic program. Staff dedicated to serving ELs, versus a program that is solely delivered by classroom teachers, provides increased support for the needs of students learning a second language. Hiring an EL coordinator to increase ELD and provide translation and support in other academics is an increased level of support above a basic program. Counselors and psychologists will address the behavioral and academic needs of

targeted student groups to engage them more fully at their school sites, promoting improved attendance and their overall school success. (This action is not for IEP assessments of students or for other Special Education services.) Families in low-income situations often struggle to provide nutritious meals including breakfast and lunch for their children. The district's food services program will ensure that well-balanced meals meeting national requirements are provided to students daily, thus improving their attention to academic learning and improving social/emotional well-being. There are numerous benefits associated with the discipline of learning music which carries over to academics and also motivates school attendance. Low-income families are also less likely to devote limited resources and time to music lessons or instruments. In addition, EL paraprofessionals have been offered additional work hours in order to provide increased services and interventions for all ELs (G1A7).

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

FESD's planned percentage to increase and improve services for low income, foster youth, and English learners is nearly 42%, which far exceeds the 31.88% required minimum. This is accomplished through the LEA and school wide actions described and justified in prompt 1. In addition, the following limited actions contribute to meeting the minimum 1:1 requirement. The following services provide an increased level of support designed to improve the learning and increase the performance of students in identified high-risk groups on both SBAC and local assessments. Services for the district's foster youth, English learners, and economically disadvantaged students are being addressed in the following ways: The total full-time equivalent (FTE) of the district's English Language Development (ELD) teachers is continuing to be increased in order to provide added support for all identified English learner students in all schools (G2A2). Additionally, supplemental materials and a new program designed to provide EL help and support will again be purchased for use in designated daily 30-minute pull-out services to provide increased support (G2A4). To help support the district's lower-achieving low-income students, the district has hired four additional intervention teachers for the 2022-23 school year to help bolster academic achievement in core subject areas (G2A2). Our district's foster and homeless youth are tracked by our full-time Foster/Homeless Youth Liaison. That individual coordinates with classroom teachers to make sure those students are receiving the academic supports needed as well as making sure their physical needs are addressed as well. (G2A2). Our Foster Youth Liaison will also be working with families who are homeless and with foster parents to help ensure that students from those families have the proper support systems in place to help them be successful and assist in making ongoing academic progress. If there are indications that any student within these categories is not receiving adequate support or appears to be falling behind academically, the Foster Youth Liaison meets with teachers, counselors, parents, and foster parents in order to plot a course of action to assist the student(s) in getting back on track (G2A2). The district has seen increased results in district administered assessments in students' ELA scores which is likely attributed to a change in student to adult ratios which has allowed for increased 1:1 support for foster youth, English learners, and low-income students. As previously mentioned, due to stakeholder input, additional teachers have been hired to help lower class sizes all across the district. Smaller class sizes allow for more individualized support for our unduplicated students which in turn. leads to increased academic achievement.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

The district plans to use its allocation of additional concentration grant add-on funding to support the employment of another full-time intervention teacher at the middle school level and another full-time intervention teacher at the elementary level. Both teachers will work with lower performing students, as identified through local assessment data (Renaissance Learning's STAR math and STAR reading) and will initially concentrate on lower performing unduplicated students. Those students who receive additional academic intervention will continue to be periodically assessed so that individual progress data can be monitored in order to cycle as many students as possible (at least those showing adequate growth and progress) through the program (G2A2).

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
