

Projected Revenue by Fund Source




This chart shows the total general purpose revenue Kneeland Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Kneeland Elementary School District is \$733,410, of which \$601,432 is Local Control Funding Formula (LCFF), \$80,082 is other state funds, \$268,466 is local funds, and \$250,550 is federal funds. Of the \$601,432 in LCFF Funds, \$30,696 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


Expenses that did not get captured in the LCAP are related to normal business costs in running a school. Those costs include utilities, legal counsel retainers, annual auditor fees, administrative office supplies. Additionally, we contract our Business services with Northern Humboldt Union High School District. All of these costs do not directly impact students so they were not identified in the LCAP.

Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Kneeland Elementary School District is projecting it will receive \$30,696 based on the enrollment of foster youth, English learner, and low-income students. Kneeland Elementary School District must describe how it intends to increase or improve services for high needs students in the LCAP. Kneeland Elementary School District plans to spend \$47,493 towards meeting this requirement, as described in the LCAP.

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Kneeland is a Necessary Small School with an enrollment of 32 students, transitional-kindergarten through eighth grade. The three-room school is located in the mountains between Eureka and Arcata which is about a 40 minute drive from either city. The school is at an elevation of 2950 feet and is surrounded by pastures, grassland, and forest. Kneeland School has an outstanding staff consisting of three classroom teachers, and a Resource Specialist and Speech Therapist. In addition, there are four part time Instructional Aides. The instructional aides also act as an administrative assistant, one Bus Driver, one back-up bus driver, one aftercare director, and one Custodian. Mission: As a focal point of the community, the Kneeland School District is committed to offering each child a quality education founded on values exemplified in rural schools: a close bond among staff, student, parents, and community, and an individualized program meeting the varying needs of all students.

Kneeland has no English Learners, Foster Youth or Homeless students enrolled. Metrics related to these groups are, therefore, not applicable.

The California School Dashboard does not report results for any state indicator due to the small size of the student population and the necessity for confidentiality.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Kneeland School District serves a small student population. The California School Dashboard is largely not applicable due to LEA size and the necessity for privacy adherence. Results on DataQuest indicate student performance in English/Language Arts and Math are as follows: In ELA 47.62% meet or exceed standard and in Math 14.29% meet or exceed standard. As these results are based on small numbers meaningful insights for long term planning are limited, as one student's performance is weighted so heavily when calculating percentages. For this reason Kneeland monitors individual student growth from year to year as a more reliable measure of success. The prior year, ELA scores were 42%, showing that performance has increased in ELA by 5%.

The LEA has sustained its enrollment regardless the re-opening of other schools in the district post-COVID.

The LEA identified students with increased needs and has provided solid resource programs including an increase in one-to-one and small group instruction with instructional aides and resource specialists. The LEA has hired a third classroom teacher, decreasing the class size to provide dedicated, specific instructional strategies for all learners. The LEA has hired an instructional aide who also serves as the aftercare program director thereby providing all students access to 9 hours of instructional time daily. The LEA has hired an additional instructional aide who also acts as a custodian; this aide assists in meeting the UTK ratio requirement of 1:10 for the primary grades' classroom, and also provides an increase in one-to-one and small group instructional supports.

The LEA has trained an additional bus driver to ensure that all students have an equal opportunity to access in-person instruction and to eliminate transportation challenges for our furthest traveling students.

The LEA has upgraded the campus to provide students and the community with fencing to create a more secure, outdoor basketball court, and a concrete retaining wall around the playground for use by our community. The campus is frequently used by community entities including the California Fire Department and the Kneeland Fire Protection District for a physical fitness regimen, and community families desiring a safe place for their young children to play.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

The current mathematics curriculum in grades 3 through 8 has been identified locally to have some weakness and will be modified and upgraded to include a more broad and thorough curriculum program to provide all learners access to a rigorous math program. Staff, both classified and certificated, have been asked to find areas in mathematics that they can garner professional development and bring back to the team to broaden the scope of the LEA's mathematical program.

The LEA currently lacks a GATE program for additional learning opportunities for high-achieving students. The LEA is investigating opportunities to implement more challenging programs and learning opportunities for high-achieving students.

The LEA is currently searching for a new resource specialist to support students with disabilities and students with IEPs.

The LEA continues to have a high rate of chronic absenteeism and the LEA will continue to reach out to those families for solutions and assistance.

During February and March of 2023, the LEA saw unprecedented storms leaving the campus inundated with 5' to 6' of snow for three weeks, and significant, lengthy spells of power-outages. The LEA received a generator from CDE at the end of the 2022 school year and is currently taking bids to install a transfer switch. Currently, there is no way to heat the school during a power outage, and winter temperatures are usually in the high 20's to low 30's. Additionally, during power outages, virtual supports are also not an option for most of the student body due to the rural nature of the district and the lack of internet, especially during a power outage.

The LEA is also holding community meetings and board meetings to gather feedback to create an emergency snow-response plan should the LEA face another year of devastating storms.

LCAP Highlights

A brief overview of the LCAP, including any key features that should be emphasized.

The success of Kneeland School to recognize the importance of the school as a community hub has proven invaluable during the unprecedented snowstorm in February and March of 2023. The snow levels exceeded 5'-6' on the school's campus and five school families and four staff members spent two full days moving snow away from the buildings so students and staff could safely return to school.

With the decrease in COVID protocols, the LEA was able to reinstate the all-school, full-immersion drama unit in collaboration with a local community theater. The school wrote, directed, designed, produced, and performed a one-hour play that was available at no charge to all students in Humboldt and Trinity Counties for one week, and to the community on one evening. The LEA's students performed their play to over 2000 audience members over the span of one week. The LEA will continue to focus largely on recreating strong community connections in collaboration with community entities.

Students living in isolated, rural communities where internet services are limited benefit greatly from an educational program that provides frequent real-life learning opportunities, such as field-trips, and community partnerships. This year, the LEA participated in 14 field-trips focused on community learning opportunities including professional theatrical performances, local clean-up at McKinleyville Land Trust to eradicate invasive plant species, and the LEA hosted a firefighter appreciation day for CDF and the KFPD which included a BBQ at the school and a field trip to the Helitack base where students had an opportunity to sit on a helicopter and try on firefighter equipment.

The 2021-24 LCAP prioritizes community involvement with the intention of increasing community events, and collaboration with other Kneeland entities including the Kneeland Volunteer Fire Protection District, Astronomer's of Humboldt, the local chapter of the Audubon Society, and Ferndale Repertory Theater.

Kneeland will continue to offer in-person instruction to students in a multi-graded learning environment based on a broad spectrum of study designed to manifest future success of all students.

Feedback opportunities and open discussions for the LEA are provided at Open House in the Spring, and at the beginning of each school year at Back to School Night. Feedback and results are discussed at Parent Advisory Committee meetings, and school board meetings - open to the public, and at LCAP overview meetings prior to adoption at board meetings -- open to the public.

Meetings incorporating staff, teachers, and parents occur through SSC meetings, PAC meetings, CPTO meetings, and staff meetings.

Staff, teachers and administration consults with SELPA to ensure all educational partners have opportunities to provide input.

A summary of the feedback provided by specific educational partners.

Data collected from surveys and in-person indicated parents supported the educational program and services provided by Kneeland School: It is important to recognize that the LEA is extremely small, so one response holds a large percentage rate.

83.3% of responses indicate that parents believe their children have access to California State Standards while the remaining 16.7% were neutral.

66.7% agreed their children's classroom experiences were preparing them for the next level of education (33.3% reported neutral.)

91.7% agreed or strongly agreed a nurturing learning environment, and efforts to foster attendance were in place (8.3% indicated that they had no children enrolled with the LEA and, therefore, did not agree nor disagree.)

75% believe staff were inclusive and they felt welcome, 75% felt morale was high (25% reported neutral).

Response rates:

60% from families, 100% participation rates from students, and 100% participation from staff.

Specifically noted and valued student input:

It's been an challenging year with so many bus issues and weather issues and the flexibility of everyone involved has been admirable! Good team work.

The kids would benefit from structured and organized project due dates. Having very clear expectations will help them later in life. For example, when at work or college these kids will have learned how planning and time management will better their productivity and their studies. This may even benefit students who are behind, allowing those that are ahead or on time with projects to assist others. Working on major projects well before they are due is better for the kids and staff, creating less stress, and less last minute chaos.

100% of teachers have consulted with SELPA to ensure student successes for all learners, targeting specifically students with special education needs. SELPA consultations are utilized as needed throughout the year, and annually.

Kneeland has consulted with the SELPA to assure that the LCAP sufficiently addresses the needs of Special Education students.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

Educational Partner input has emphasized the desire to implement a permanent third class to increase student successes in all areas of study, focusing on primary grades and targeted learners with specific needs. The inclusion of a permanent third classroom decreases the number of grades in each class from 5 grade levels to 3 grade levels in each class which would promote a more focused, rigorous educational program appropriate for the skill levels in each instructional cohort.

Based on educational partner input, an before-school and an after-school program were established and trained staff was hired to run and supervise the program. The LEA is investigating implementation of intersession instructional opportunities and a longer after-school program.

Goal 1, Actions 1, 3, 7, and 8 directly relate to educational partner input through employing trained certificated staff to promote rigorous educational programs, the employment of trained instructional aides to provide one-to-one and small group supports, the acquisition of state standard materials, and the implementation of monthly field trips to accent real-life learning opportunities for all students.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

With a small testing pool available, caution should be taken when interpreting percentage results. In 2021-2022, 9 students were tested for PE; one student fell only slightly below the the healthy fitness zone standard making the percentage fall 11%. For State Testing, 21 students were tested including 5 students with special educational needs and challenges.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Goal 1.1 -- The LEA hired a third teacher to create smaller classrooms.

Goal 1.9 -- This was higher than budgeted due to ELOP Funds; the LEA increased the services to pay for school bus training out of these funds.

Additional funding became available through the Arts Block Grant which allowed the LEA to increase instructional materials, supplies, and field trips to support arts education opportunities. This is reflected in an increased expenditure in action items 1.7 and 1.8. Additional funding became available through UPK and ELOP, providing opportunities to increase instructional aide staff which is reflected in an increase expenditure in action 1.7.

An explanation of how effective the specific actions were in making progress toward the goal.

The LEA hired a permanent teacher for the TK-2nd grade classroom. This has decreased the grade spans in each class and has decreased the number of students in each classroom. Through the addition of a third teacher coupled with the increase in instructional aide time to satisfy the UPK ratio requirements, students in the primary grades room are receiving small group and one-to-one instructional learning opportunities to combat any learning loss and strengthen educational foundations in the initial instruction years. Returning to the full immersion drama unit through a partnership with a local community theater has increased attendance rates during the difficult weeks between Thanksgiving break and winter break. The drama unit also strengthened our students' relationship with their community, has developed an understanding of the art culture of our county, and has broadened our students' educational opportunities while also giving back to our community. The students created, designed, produced, and performed a one-hour play that was free for all students in Humboldt and Trinity counties to attend during the day for one week, and for all community members and families to attend at no charge on Wednesday evening. This unique opportunity brought to our students learning venues seldom explored in elementary school and it created strong bonds between our students, and between our students and their community.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Through reflection of the actions, goals, and progress made toward those goals, the LEA will revisit its current after-school care program. Parent surveys have revealed the priority for families to have longer after-care instructional opportunities. Through the ELOP, the LEA intends to restructure the after-care program to extend longer in the evenings for working families. Based on state testing results and feedback from educational partners, the LEA is investigating enriching mathematics curriculum and learning opportunities to increase student successes in math. The LEA will continue to work closely with SELPA and resource personnel to ensure that all students needs are being met, including students with disabilities, foster and homeless youth, and students with learning loss and unique instructional requirements.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

There was a measurable increase in expenditures for the 2022-2023 school year for repairs and upgrades to the school. A safety inspection manifested an unsafe playground slide which was removed and the equipment was restructured to make the apparatus safe. A combination of planned upgrades coupled with emergency repairs increased expenditures to maintain the facility. Additional expenditures in professional learning reflect a classroom and behind the wheel training program for a second bus driver.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 2.1 -- the increase was due to improvements to campus security with the removal of a rotten, wooden fence and installation of a new fence. A concrete perimeter was installed around the play structures on the field to separate the play area from the open field. The ramp to the potable was replaced and repainted. A broken slide was removed and the play structure was modified to make the apparatus safe for all students. Due to an unprecedented snow storm and an earthquake, two heaters on campus were blown with the repeated power outages, a hole was ripped into the roof of the main school building, and significant water damage occurred to the false ceiling. Repairs ensued to keep the campus safe for staff and students. Additionally, the LEA hired local crews with large bulldozers and equipment to move massive amounts of snow away from the buildings to allow the LEA to open the school for instruction.

Action 2.2 -- The increase was due to identified UPK Funds to go towards any training or professional development for prek.

An explanation of how effective the specific actions were in making progress toward the goal.

Through immediate attention to necessary repairs, the LEA was able to open for in-person instruction in the middle of an immense snow storm. Having school in session provided access to educational opportunities and a rigorous curriculum for all students including students with disabilities, foster and homeless youth, and students targeted as having learning loss.

The increase in UPK funds will be utilized to upgrade the TK classroom for younger students as well as increase professional development opportunities for the primary grades' teacher.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Through thorough examination of the campus and facilities following the earthquake and the snow storm, areas of exposed siding were discovered as well as further damaged areas due to the weight of the snow. These impediments will be address over the summer to repair any structural damage and repaint the school buildings. Additional, portable fencing will also be installed to prevent students from accessing the parking lot during heavy traffic times which will further secure the campus from potential hazards. As per the UPK requirements, the current play structures are being assessed for age appropriateness and additional playground equipment will be installed in the next two years.

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Transportation expenditures increased with the implementation of a second bus as well as frequent bus services required for the LEA's larger bus.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

3.1 The increase is due to additional hours required to assist the administrator with reporting and maintaining the school during the snow storms, power outages, and the earthquake in December. The secretary also received a stipend for coordinating the full-immersion drama program in collaboration with Ferndale Repertory Theater.

3.2 Expenditures in transportation increased due to frequent mechanical issues with the larger bus. The LEA was able to rent a smaller bus and utilize the LEA's second, trained bus driver to implement two bus runs whenever the larger capacity bus was out of service. The increased expenditures reflect the rental fees of a smaller bus, the service fees for the out-of-service bus, and the supplies necessary to repair the bus. The LEA plans to purchase a new bus or van in 23/24 to replace the existing bus that has mechanical issues.

An explanation of how effective the specific actions were in making progress toward the goal.

The two bus runs allowed the LEA to maintain transportation opportunities for all students and support stable attendance by all students including students with disabilities, foster and homeless youth, and students targeted as having learning loss. Two bus runs also transportation for all students during field trips.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Due to the unreliable status of the larger capacity bus and feedback from educational partners, the staff and school board are investigating the acquisition of a new bus. The implementation of a second driver has increased the LEA's ability to satisfy the transportation needs of families and has assisted in maintaining a stable attendance rate.

 Action 3: Instructional Aides: Instructional Aide time has been increased as appropriate to maintain a 1:10 adult to student ratio in the TK classroom as allowing unduplicated students to receive more individual instruction. The additional instructional aide time is also being utilized to satisfy the ELO-P 9-hour day instructional time. The instructional aides are able to support students with direct, one-to-one instruction or small group instruction , prioritizing the specific needs of foster/homeless youth, and low-income students. The LEA does not currently have any English Learners.

Action 4: Technological devices have been purchased to maintain a 1:1 ratio for students to devices which is a specifically identified need for our unduplicated students. Laptops were purchased to ensure that each student has access to the testing site. High-Speed internet has been purchased and offered at the school through in-person instruction, but also in the parking lot and at a community learning hub in the LEA library for anyone in need of connectivity.

Action 8: Fieldtrips: The LEA has implemented monthly field trips and presentations to increase access to real-life learning experiences throughout the county. Considering unique learning pathways for students, these field trip opportunities will provide foster/homeless youth, low-income students with learning opportunities above and beyond the classroom. The LEA does not currently have any English Learners

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
