

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Redwood Preparatory Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Redwood Preparatory Charter School is \$3,319,738, of which \$2587042 is Local Control Funding Formula (LCFF), \$477,187 is other state funds, \$130374 is local funds, and \$125135 is federal funds. Of the \$2587042 in LCFF Funds, \$180340 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Redwood Preparatory Charter School is projecting it will receive \$180340 based on the enrollment of foster youth, English learner, and low-income students. General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Redwood Preparatory Charter School is a community of learners that exists to inspire each student to academic excellence using research-based best practices and innovative means to build a passion for learning, a solid foundation of knowledge, and a strong sense of social responsibility. We are a public charter school operated by the non-profit organization Dream It. Be It. Incorporated. Our school is located in Fortuna, a rural community in the Eel River Valley of Humboldt County.

The 2022-2023 school year marks our twelfth year of operation serving 221 students from transitional kindergarten through eighth grade. Our student demographics are as follows: 77.4% White, 9.5% Hispanic, and 13.1% Other. 41.2% of our students are identified as Socioeconomically Disadvantaged, 16.3% receive Special Education services, 7.1% are designated as GATE . 0.5% (1student) designated as an English Learner, and no Foster Youth. 2.3% of families are eligible for McKinney Vento services.

High school related priorities such as advanced placement courses, high school graduation and dropout rates, or college preparedness do not apply to this school. As a Charter School, we are not required to adhere to the Williams Act or required to adopt state mandated curriculum; however, our facilities received a rating of good on the Facilities Inspection tool and all our teachers are appropriately credentialed. At Redwood Preparatory Charter, we operate without a bargaining unit for either certificated or classified employees.

Our school embraces five core values: Academic Excellence, Sense of Community, Social Responsibility, Collaborative Leadership, and Educating the Whole Child. Redwood Preparatory Charter School is committed to offering a quality, rigorous and meaningful educational program that sets students on the path to college or trade school, and empowers students to become productive, healthy, ethical citizens in a rapidly changing society. Through a curriculum based on core academic standards and research based best practices, we empower students to become self-motivated, lifelong learners. Utilizing assessments and data to guide our instruction, we ensure that all students reach their highest levels of academic achievement. Through participation in classroom, school, local and global communities, Redwood Preparatory Charter nurtures respect for diversity and civic responsibility. We establish a vigorous learning community that reflects and supports our

common, core values. Children develop social responsibility and feel a greater sense of belonging in an environment which promotes close, long term relationships between classmates and teachers. In an atmosphere of collaboration and family involvement, which embraces considerate and clear communication, we believe that children flourish and grow to be healthy, competent, engaged members of our society.

Students thrive when offered opportunities to expand experiences through enrichment. We foster a culture of exploration through programs and choices that promote individual and collaborative inquiry. We aim to educate the whole child by integrating drama, music, art, social-emotional learning, technology, and wellness into the curriculum. These experiences teach students to problem solve, work creatively and develop perseverance. By integrating our five core values, Redwood Preparatory Charter School is committed to educating students that are equipped with the essential skills, knowledge, and passion for learning that are critical for success in the 21st Century. According to the California School Dashboard, we have much to celebrate and growth still to be made.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

This has been a great year at Redwood Prep! We are so proud of the academic progress of our students and recognition from the state as a California Distinguished school! The California School Dashboard indicates that as a school, all students scored in the high range for both language arts and math as well as students identified in the socio-economically disadvantaged (SED) subgroup. We focused intervention services on students in 2nd and 3rd grades which significantly impacted the number of students achieving at grade level. Student, family and staff surveys reflect that educational partners feel safe and connected. We expanded our nutrition program and successfully navigated a review by the state with no findings! Student council members in grades 6-8 participated in the Eel River Valley Student Leadership Academy in order to grow their capacity as student leaders. Forty students and seven staff members were trained as student ambassadors and staff leaders to help students stand up to bullying as upstanders. Our shared leadership groups resumed activities which led to successful fundraising at our gala. The Grandparents in Action group joined students on the playground each Tuesday, sent kids home with treats once a month and celebrated our staff with monthly luncheons. Families joined together for a jack-o-lantern carving contest, a Bocce Ball tournament, a dog walking challenge to benefit shelters, Family Feud Night and sign making! Student athletes competed in all sports this year and our musicians resumed making music!

All metrics were met and the actions contributed positively to a safe and clean school environment for learning.

Expenditures are slightly more due to replacing more HVAC units. We plan to us grant funding to cover half of the funding in 2023-2024.

Our survey results (Metric 1.4) indicate an increase in the number of students who feel safe on campus as well as the number of parents who believe their children are safe. This is likely a result of the release of Covid restrictions as well as increased safety measures (Action 1.2). We participate in regular safety training and drills with our students. This year, we hosted an informational meeting for our TK and K parents to educate them about our safety practices. We installed a "panic button" so that an all school lockdown could be initiated from multiple locations on campus and added boosters around campus to improve the range of the panic buttons.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Redwood Prep has done an excellent job minimizing student learning loss. Overall, our students scores were in the High level for both ELA and math. We slightly increased math scores (2%) and dipped slightly in ELA (2%). We saw a minimal loss in ELA scores (2%) for students identified in the SED category but an exciting increase in math scores for this subgroup (9%). Redwood Prep was recognized as a CA Distinguished School based on test scores for our students. (Metrics 2.1-2.5) We continue to focus intervention services for our students in grades 1st, 2nd & 3rd grade because they suffered a critical loss of hands on learning as a result of the pandemic (Action 2/4). Our local results indicate a significant improvement by 2nd and 3rd grade students who attended reading intervention. We increased services this year and were able to provide extra support for more students. Each year we have an increasing number of students who identify as LGBTQIA. Our staff received training (2.16) to educate us about how to best support these students at school according to the law.

We were unable to hire a school counselor. (Action 2.10)

An explanation of how effective the specific actions were in making progress toward the goal.

Based on the designation by the state as a California Distinguished School; we achieved amongst the top in the state. The area we have made the least progress is finding a school counselor. This year we provided friendship groups and one on one support as needed using teaching staff to serve students. When issues came up for students at a higher level, we reached out to the Humboldt County Office of Education or made a referral for services through the Bridges Grant (Action 2.10).

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Redwood Prep students need to be healthy and strong physically to support learning in the classroom. We plan to improve our physical education and health education instruction and to purchase resources for PE. (2.19)

Increasingly, our students struggle with perseverance and the grit needed to continue trying even when things get tough. The development of a growth mindset has always been a foundational approach at Redwood Prep. We cite Habits of Mind in our charter petition as an integral part of our learning program. Over the last few years we have added new staff and students have lost out on instruction around the development of Habits of Mind. We dedicated funds to offer introductory and refreshers for our staff as well as materials to support instruction. (2.20)

Social emotional needs continue to be a top priority at Redwood Prep. Until we find a counselor, we are looking for resources to support our students and staff beyond the SEL curriculum. We plan to purchase a library of trade books to use across grade levels to initiate dialogue and support SEL learning. (Action 2.21)

We have increased the number of actions in goal 3 and increased the budget.

Last spring, we planned and implemented a series of events to bring parents and students back on campus together (Action 3.4). These events were celebratory and delivered the joy and connections that students, staff and families indicated they needed. These events reestablished the connections within our school community and set a tone to get us back on track as we began to move past the crisis of the pandemic. These events also served to initiate cross collaboration between student and parent groups. We are committed to empowering our students and ensuring they can see their voice reflected in decisions we make on campus. Last spring, we began a relationship with The Center for Systems Awareness (CSA) out of MIT. Their work is centered around building systems that meaningfully support the mission, vision and core values of an organization. They also work to develop youth leaders by teaching skills that will be needed to navigate the complex issues they will face as adults. Healthy systems lead to a generative social field that values and promotes and protects belonging for all community members. In the 2022/2023 school year, we officially partnered with CSA as a lab school in conjunction with the Humboldt County Office of Education (HCOE). As a result of this work, we sent two students, a teacher, board member and the administrator to an introductory training. We've met with students, parents, grandparents, and staff throughout the year and plan to send more students and staff to training in June. This work provides a framework to gather meaningful feedback from all community groups and empowers people to step up as leaders which enhances our core value of shared leadership. This work has allowed us to expand our practices for mindfulness and in time will support the core value of social responsibility. This work was not an action but the work was carried out and will become action 3.5 next year.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.  the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
