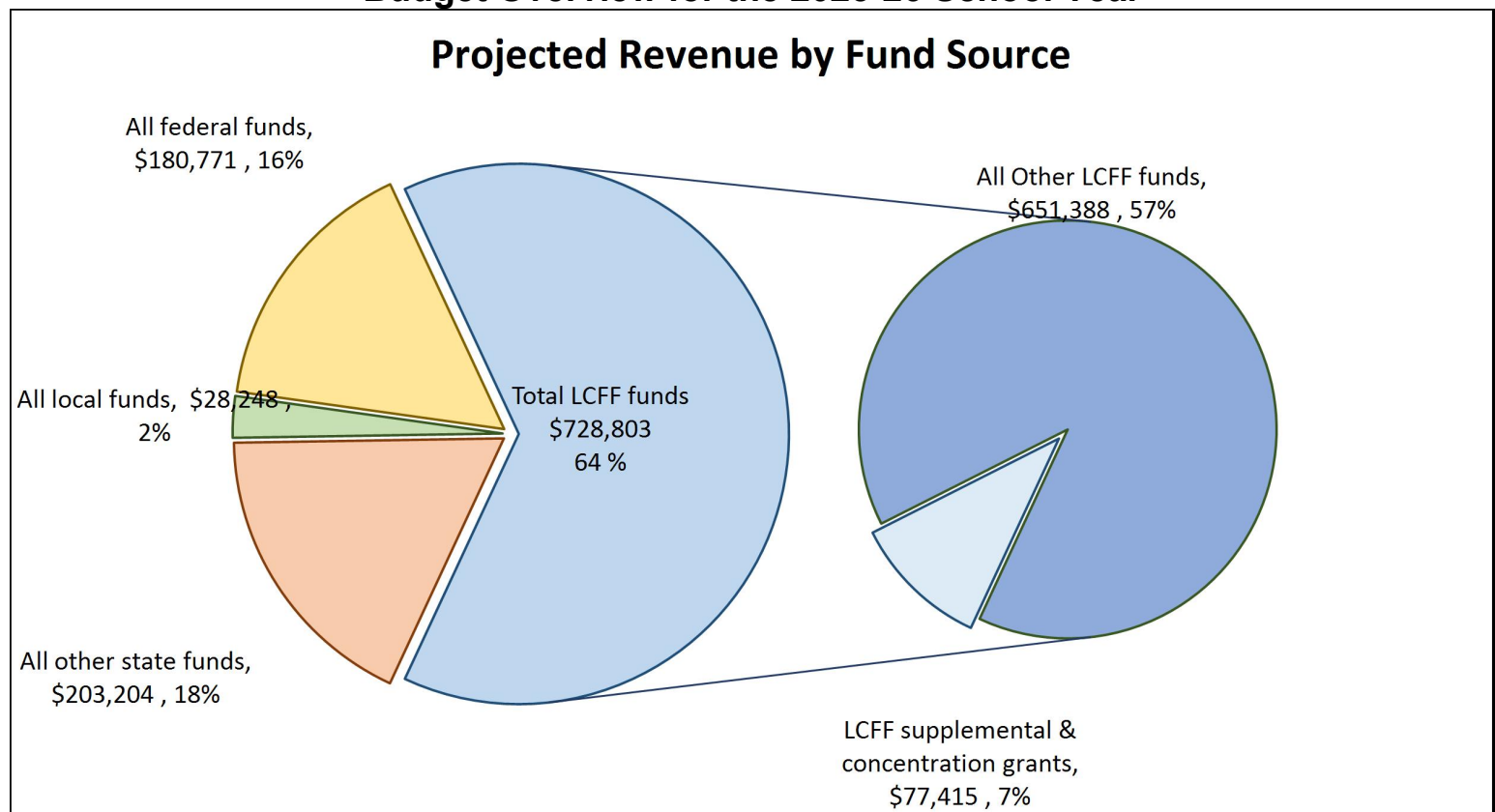

Budget Overview for the 2025-26 School Year

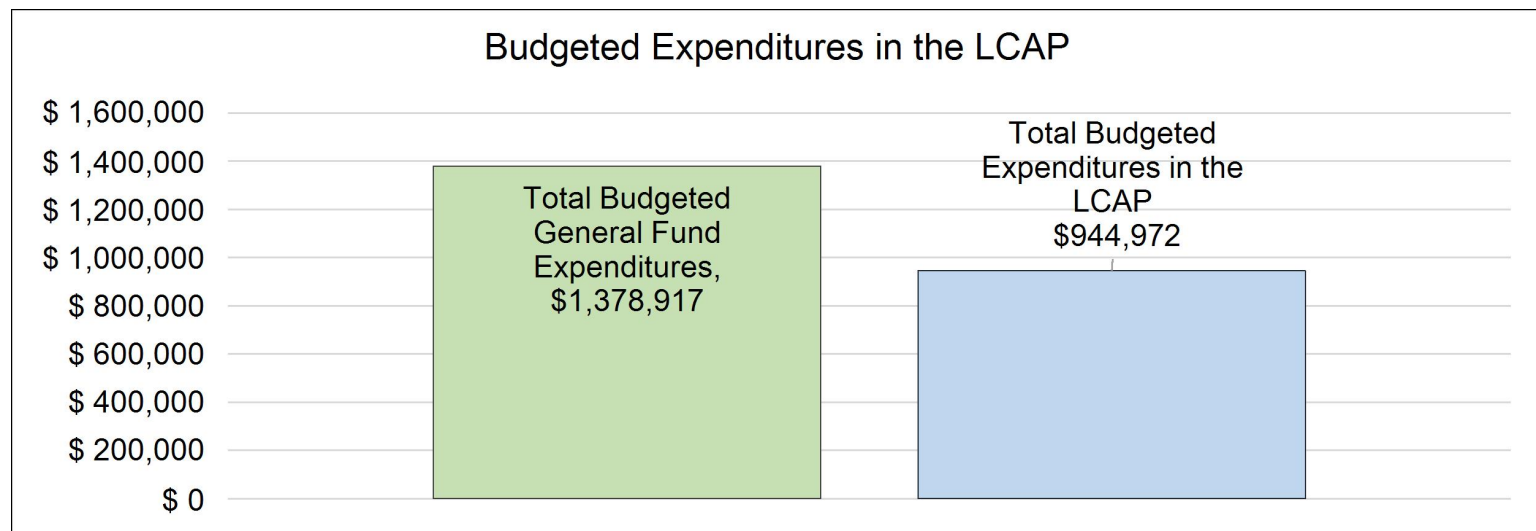


This chart shows the total general purpose revenue Bridgeville Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Bridgeville Elementary School District is \$1,141,026, of which \$728,803 is Local Control Funding Formula (LCFF), \$203,204 is other state funds, \$28,248 is local funds, and \$180,771 is federal funds. Of the \$728,803 in LCFF Funds, \$77,415 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

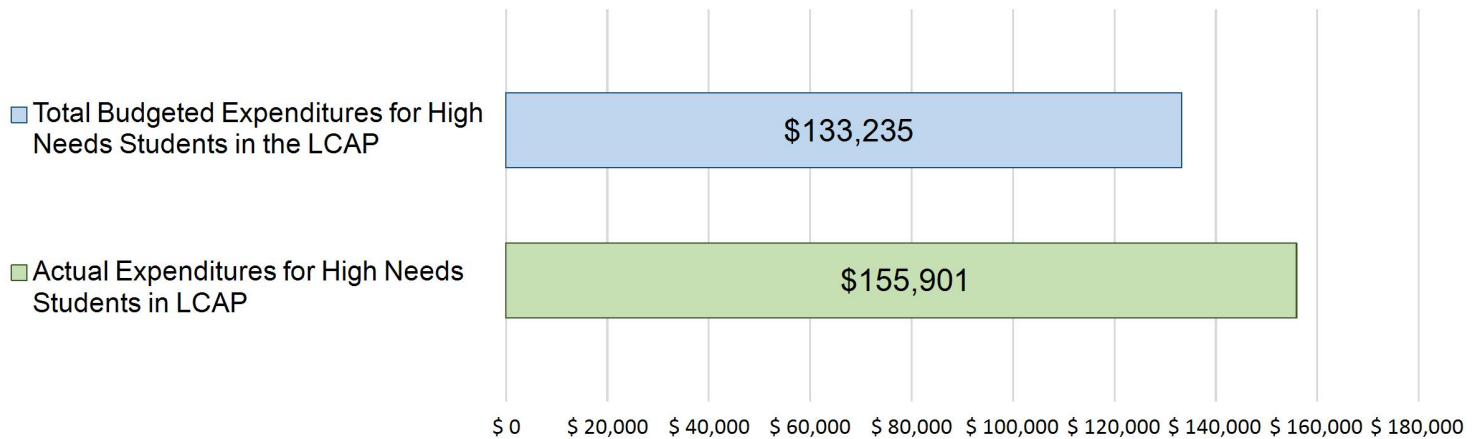
Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

General Information

Bridgeville School District is a very small one-school district that serves on average 35 to 40 students grades TK-8. The District is vast (approximately 500 square miles), remote, and economically depressed. The school has three self-contained classrooms and three regular education teachers as well as a 0.4 FTE RST, a 0.4 FTE school counselor, and online SLP and online OT services. The District is also in the process of engaging a Certified Holisitc Wellness Coach. No Foster Youth are currently enrolled in Bridgeville the past two years therefore no corresponding metrics are included. More than 90% of the student population is socio-economically disadvantaged. The District qualifies for Provision 2 of the School Nutrition Program and serves all students breakfast and lunch.

Reflections: Annual Performance

Part 1:
At Bridgeville School climate change is a welcome phenomenon. The school climate has continued to improve through the 2024-25 school year. School administration has been stabilized and hiring a 0.4 Full Time Equivalent (FTE) school counselor coupled with strategically targeted professional development has positively influenced social-emotional support systems throughout the school. A recent bond measure has enabled the district to make significant facility improvements adding to student, staff, and community pride in their school. 2024 Dashboard indicates slight decline in overall test results in English Language Arts (ELA) and a more significant decline in Math. Chronic

absenteeism remains an area of concern and a focus of district resources. For 2024-25, Basics: Teachers, Instructional Materials, Facilities - Standard Has Been Met; Implementation of Academic Standards - Standard Has Been Met; Parent and Family Engagement - Standard Has Been Met; Local Climate Survey - Standard Has Been Met; Access to a Broad Course of Study - Standard Has Been Met. Based on the 2024 Dashboard, Bridgeville is eligible for Differentiated Assistance (DA)based on continued chronic absenteeism.The District has partnered with an assistance team from the Humboldt County Office of Education (HCOE) to address the attendance. In addition resources from the California Community Schools Partnership Program, in conjunction with the official District Attendance Team composed of school staff and parents, are being used to encourage students and families to attend school regularly and on time. Several meetings were held throughout the year to assess data and input and to devise strategies to address relevant issues. The HCOE team conducted an all-day input data survey of all students, staff, and parents in November. Plans for year two include Fall and Spring surveys to facilitate establishing a growth comparison over time and developing further strategies to address relevant issues. A Fall 2024 survey was done in November and a Spring 2025 survey is pending.

The district has taken the following steps to address chronic absenteeism: 1 Hired a 0.4 FTE school counselor to help meet the social/emotional needs of all students and staff. 2 Initiated Positive Behavioral Interventions and Supports (PBIS) program in January 2025 to continue into the 2025-26 school year. 3 Established an Attendance Team to investigate attendance and positively support families getting students to school regularly and on time. 4 Maintained attendance goals and incentives. 5 Provide all staff with professional development in social/emotional needs related to attendance and learning. 6 Worked with the Humboldt County Office of Education support staff in a comprehensive school climate/needs survey to guide development of resources. 7 Instituted a School Garden Program to broaden and enrich curriculum. 8 Significant facility improvement to enhance campus appearance and function.

Input from all constituents listed above, whether originating from an LCAP specific event or discussion or a school/climate survey, school-relevant information related individually to an administrator or other school personnel, school climate/needs survey has been used to guide the progress and process of the district LCAP. More Social/Emotional Learning professional development for all staff and hiring a 0.4 FTE school counselor were added to the LCAP as a result of input from educational partners. Input also indicated a need for improved school to home communication which was addressed through the In Touch online program and regular classroom to home communication.

An explanation of why the LEA has developed this goal.

This goal was developed in conjunction with our educational partners in response to the identified academic needs of our students based on state and local data.

The analysis of the limited data reported on California School Dashboard (Dashboard) indicate a clear need to continue supporting English Language Arts (ELA) and mathematics. For example:

* the average of the scores of all students in grades 3–8 in English Language Arts on the Smarter Balanced Assessment is 95.3 points below standard.

* the average of the scores of all students in grades 3–8 in Mathematics on the Smarter Balanced Assessment is 111.5 points below standard.

It must be noted that due to the small student population in the Bridgeville School District the number of SED students and other groups is too small to generate publicly released reports on the California Dashboard. As there fewer than 5 EL students, no report of ELD progress is reported, and similarly, with no Foster Youth enrolled there are no reports for that group.

Additional student outcomes related to academic performance are found in the Measuring and Reporting Results section. (Priority 8)

- » Ongoing instructional support for ELA, mathematics, and ELD
- » Increased collaboration time for teachers
- » Assistance to SED and EL families in understanding the online tools and student management system so that they can better support their student(s) at home

- » Access to reading materials for students who are SED to be used at home
- » Supportive learning environments at home for foster youth

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All actions were implemented as planned with the exception of the following.

1.1 Extended Summer Program - The summer program was discontinued midsummer due to minimal attendance. Transportation, conflicting family plans, and general interest were factors that limited attendance.

1.4 After School Program - Both All Students' ELA and Math CAASPP Scores declined indicating additional support in those areas. The 2025-26 After School Program will focus on ELA and Math support.

1.6 Instructional Materials for all students - Due to the decline in CAASPP scores mentioned in 1.4, the district is considering a new math adoption and adding Next Gen Math supplemental materials.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Actions:

1.1 Extended Summer Program. -19% The program was terminated mid-summer due to insufficient attendance.

1.2 Additional resources for home use. -100% (\$851) No supplies were requested.

1.3 Professional Development (PD) . +64% More professional development opportunities than expected were available.

1.6 Instructional Materials for all students. -52% Planned curricular adoptions were not completed.

1.8 Student Events and Enrichment. -64% Not all planned activities were completed.

1.12 Technology Resources. -25% Erate funding increased.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

All relevant actions were implemented as planned.

Action 1.2 - Additional Resources for Home Use: Although Metric 1.3 ELA CAASPP Scores (P4) showed a decline of 17.7 points and Metric 1.4 MATH CAASPP Scores (P4) showed a decline of 54 points the District intends to continue making resources for home use available to all learners including ELA and Low Income students. The effectiveness of the Action will be reevaluated in the spring of 2026. Metric 1.3 and Metric 1.4 will be used to monitor progress.

Action 1.10 - Increased Certificated Staffing: Although Metric 1.3 ELA CAASPP Scores (P4) showed a decline of 17.7 points and Metric 1.4 MATH CAASPP Scores (P4) showed a decline of 54 points the District feels that provide the maximum certificated FTE to maintain small class size and grade a span maximum of three grades is an effective strategy to increase student achievement. The effectiveness of the Action will be reevaluated in the spring of 2026. Metric 1.3 and Metric 1.4 will be used to monitor progress.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

No changes were made regarding planned goals, metrics, or target outcomes. Changes in actions were made as follows.

1.1 Extended Summer Program - Home to School transportation will be provided and communication and promotion will be fortified.

1.4 After School Program - More certificated support and focused coaching will be provided in the areas of ELA and Math.

1.6 Instructional Materials for all students - As stated above, due to the decline in CAASPP scores mentioned in 1.4, the district is considering a new math adoption and adding Next Gen Math supplemental materials.

1.14 - Certificated Support: Metric 1.3 ELA CAASPP Scores (P4) showed a decline of 17.7 points and Metric 1.4 MATH CAASPP Scores (P4) showed a decline of 54 points. Action 1.14 was added to engage a 0.4 Full Time Equivalent (FTE) to 1.0 FTE Certificated Curriculum Specialist to support all students, including students with disabilities, in ELA and Math. Progress will be monitored using Metric 1.3 and Metric 1.4.

This Action is fully funded with LREBG funds.

An explanation of why the LEA has developed this goal.

This goal was developed in conjunction with our educational partners in response to the identified need for student and staff sense of safety and school connectedness based on state and local data, including climate surveys, as well as chronic absenteeism and suspension rates.

The analysis of California School Dashboard (Dashboard) data indicated a clear need to continue supporting outcomes related to students' sense of safety and connectedness. For example:

- » The chronic absenteeism rate for all students in grades K–8 was 29.5%. This was an increase of 4% from the prior year.
- There are no group reports for SED, EL or FY as student numbers are too small.
- » The suspension rate for all students in grades K–8 is 0%.
- There are no group reports for SED, EL or FY as student numbers are too small.
- » The middle school dropout rate for all students is 0%.
- There are no group reports for SED, EL or FY as student numbers are too small.

Our team conducted a root cause analysis to determine the causes of higher rates of chronic absenteeism. It was determined that lack of school connectedness was one of the leading causes of chronic absenteeism.

During the district's educational partner engagement process, families suggested that the district maintain our comprehensive counseling programs in order to provide social and emotional support for students, and professional development in restorative practices for all staff.

To ensure that students are prepared for college and careers, the culture and climate of schools must be conducive to learning and promote a sense of connection and belonging. Through professional development in SEL for all school staff as well as continuing access to the school counselor, we expect students to feel more connected to school, which will improve outcomes.

All relevant actions were implemented as planned with the exception of the following.

Action 2.2 Social emotional Learning Training and Social Emotional Health Training - Metric 2.6 Sense of Safety and School Connectedness yielded an increase of 5% students feeling safe at school, an 8% increase in students having a staff person to talk to, and no change in parents feeling comfortable talking to school staff. The District cautiously interprets these statistics to indicate the effectiveness of Social emotional Learning Training and Social Emotional Health Training. The 2025-26 School Climate Survey may help clarify that interpretation.

Action 2.5 Transportation - Metric 2.2 Attendance Rate (no change) and Metric 2.3 Chronic Absenteeism (down from 29.5% to 11.1%) indicate overall effectiveness of the action.

Results of the annual Bridgeville School Needs Assessment Survey indicate a continuing need for Home-to-School transportation. Efforts to acquire a school bus are ongoing although, to date, unsuccessful. The District is committed to offering Home-to-School transportation asap and at the beginning of the 2025-26 school year at the latest. To facilitate participation in the After School Program and Summer Programs and field trips the District has purchased a new van. Given the results of efforts during the 2024-25 school year and plans to expand expand home-to-school transportation the District anticipates continued improvement in attendance. Results of Metric 2.2 and Metric 2.3 will be evaluated in the Spring of 2026.

2.6 Music Program - Metric 2.2 Annual Attendance, Metric 2.3 Chronic Absenteeism Rate, and Metric 2.6 School Climate Survey indicate sustained or increases in positive outcomes. 2025-26 Annual Attendance, Chronic Absenteeism Rate, and School Climate Survey results will be used to clarify the effectiveness of the Action.

2.9 Meal Program - Metric 2.2 Annual Attendance, Metric 2.3 Chronic Absenteeism Rate, Metric 2.6 School Climate Survey. As a result of educational partners input it has been established that many students and especially unduplicated students require school meals to provide them with a nutritious balance diet. Due to the low socio-economic status of the District, Bridgeville School qualifies for the Provision 2 State Free and Reduced Meal Program that ensures that all students receive school meals. The positive effects of providing all students with a nutritious breakfast and lunch is directly reflected in increased attendance, lower absenteeism, and positive School Climate Survey results. Progress will be monitored using Metrics 2.2, 2.3, and 2.6 in 2025-26.
