## 2021-22 School Overview

The Humboldt County Office of Education operates programs for moderate to severely disabled students at the Glen Paul School and regional special day classes (SDC) that are located at numerous school sites throughout the county. These programs educate students with moderate to severe disabilities between the ages of three and 22 years. There are 9 classes serving 60 students at Glen Paul School and 9 classes at elementary and high school sites that serve an additional 68 students with severe disabilities.

Students are referred to Glen Paul School and the off-site special day classes by their district of residence. Enrollment is based on individual need and a recommendation from the student's Individualized Educational Program team.

Glen Paul School shares its facility with the California Children's Services (CCS) Program.

The Glen Paul School and the regional SDC philosophy/mission is to provide a stimulating, functional curriculum based on success and personal dignity in a safe, supportive environment. Enhancing social and behavioral skills continues to be a primary focus for students throughout the year.

The primary goal of the Glen Paul School and regional SDCs is to provide students with educational opportunities which maximize their strengths and allow them to gain independence at home, at school, in the community and in future job placements.

Students earn a Certificate of Completion when they complete the special education program at age 22.

## B. Pupil Outcomes

#### Statewide Assessments

(i.e., California Assessment of Student Performance and Progress [CAASPP] System includes the Smarter Balanced Summative Assessments for students in the general education population and the California Alternate Assessments [CAAs] for English language arts/literacy [ELA] and mathematics given in grades three through eight and grade eleven. #### SARC Reporting in the 2020-2021 School Year Only

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. There were no other assessment options available for the CAAs. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.

The percentage of students who have successfully completed courses that satisfy the requirements for entrance to the University of California and the California State University, or career technical education sequences or programs of study.

## Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2019-2020 data cells with N/A values indicate that the 2019-2020 data are not available due to the COVID-19 pandemic and resulting summative test suspension. The Executive Order N-30-20 was issued which waived the assessment, accountability, and reporting requirements for the 2019-2020 school year.

The 2020-2021 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-2021 school year. Where the CAASPP assessments in ELA and/or mathematics is not the most viable option, the LEAs were allowed to administer local assessments. Therefore, the 2020-2021 data between school years for the school, district, state are not an accurate comparison. As such, it is inappropriate to compare results of the 2020-2021 school year to other school years.
