### 2024-25 School Description and Mission Statement

The Humboldt County Office of Education operates programs for students with extensive support needs at the Glen Paul School and regional special day classes (SDC) that are located at numerous school sites throughout the county. These programs educate students with significant needs between the ages of three and 22 years. There are 9 classes serving 66 students at Glen Paul School and 9 classes at elementary and high school sites that serve an additional 74 students with significant needs.

Students are referred to Glen Paul School and the off-site special day classes by their district of residence. Enrollment is based

on individual need and a recommendation from the student's Individualized Educational Program team.

Glen Paul School shares its facility with the California Children's Services (CCS) Program.

The Glen Paul School and the regional SDC philosophy/mission is to provide a stimulating, functional standard-based curriculum based on success and personal dignity in a safe, supportive environment. Enhancing social and behavioral skills continues to be a primary focus for students throughout the year.

The primary goal of the Glen Paul School and regional SDCs is to provide students with educational opportunities that are equitable, maximize their strengths and allow them to gain independence at home, at school, in the community and in future job placements.

Students earn a Certificate of Completion when they complete the special education program at age 22.
