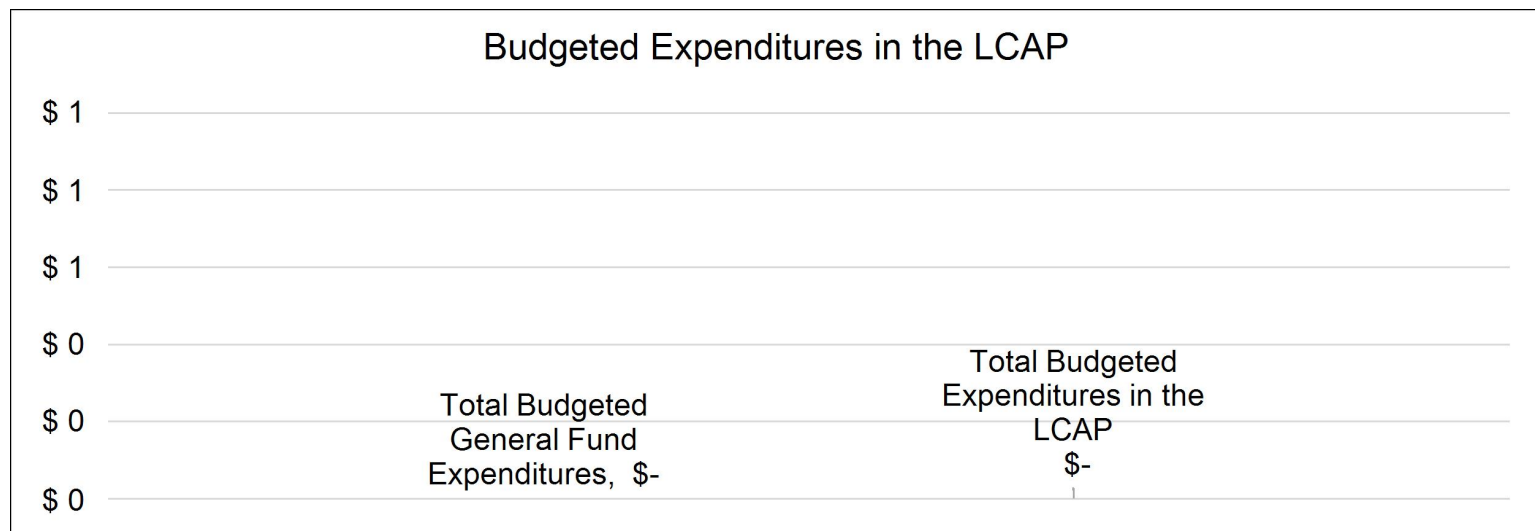

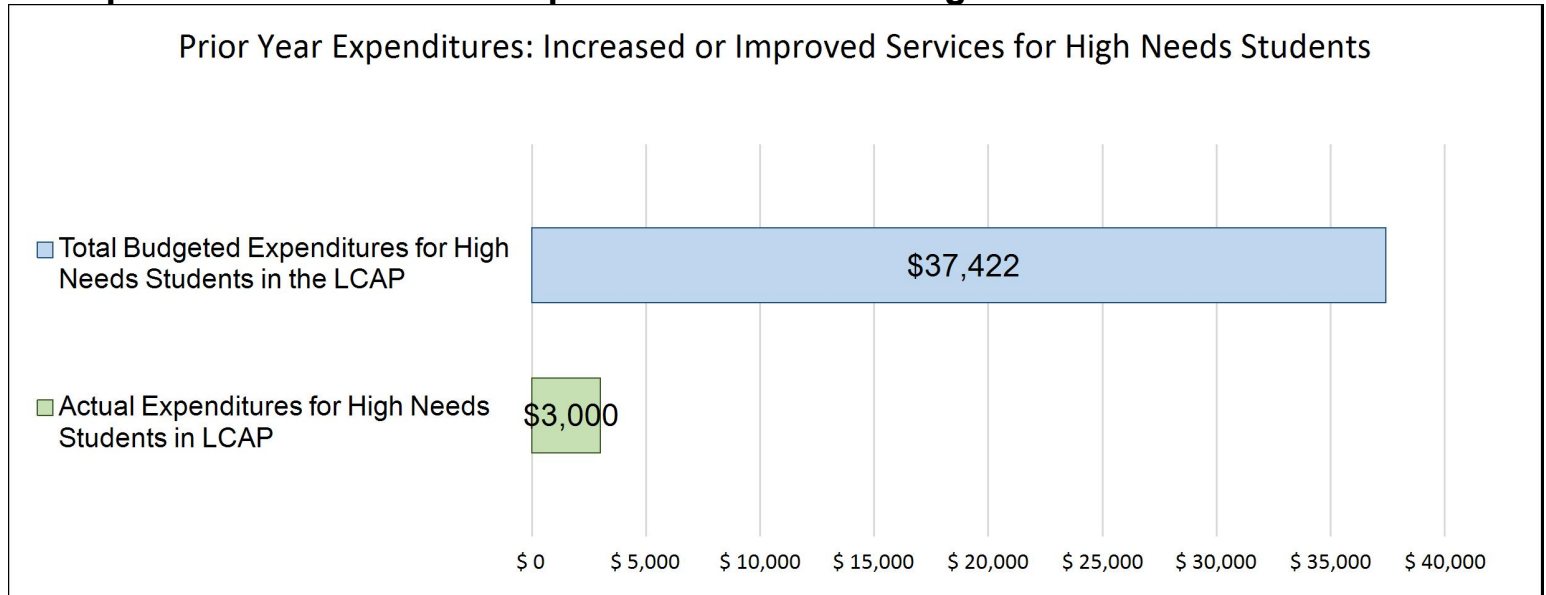

Plan Summary [2025-26]

General Information

Green Point School District has one elementary school. It is a small necessary rural school that serves TK-8 students. Green Point School is a small rural school serving grades TK--8. With 3 students enrolled (as of May 15, 2025), classrooms are multigrade level and taught by a highly qualified teacher using Common Core State Standards (CCSS) aligned materials. We provide an excellent educational opportunity that enables all students to achieve academic success and realize their full potential. We are located approximately 19 miles east of Blue Lake, California. Our school is nestled in a valley surrounded by redwood trees and adjacent to Redwood Creek. The school acts as a community meeting place for neighborhood groups including the Fire Wise Council and Neighborhood Watch. The outcomes, metrics, and results in our LCAP are an approximate for a TK--8 district. Green Point school will receive no longer receive Equity Multiplier funds after the 2024=2025 school year. This district does not have a high school, English Language Learners, or Foster Youth at this time. Therefore, the following metrics are not included:

- % who have passed AP exam with a score of 3 or higher
- %who demonstrate college preparedness via EAP or subsequent indicators
- High School dropout rates
- High School graduation rates

Due to a lack of enrollment, Green Point is no longer eligible for necessary small schools funding and will fall into lapsation at the end of this school year. The school will be closed as of July 1, 2025.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Green Point Students were enrolled in all required areas of study. Students participated in ELA, mathematics, social studies, P.E., visual, and music lessons. 100% of the teachers were appropriately credentialed. 100% of students with disabilities participated in programs indicated in student IEPs. 100% of students had access to instructional materials for Language Arts that were CCSS aligned. The school is using a Mathematics program adopted in 2023-2024 school year.

The Facilities Inspection Tool (FIT) indicated the facilities were in good repair. We are in the process of repainting our school's exterior and just need to finish the back porch area. The district maintained a student suspension and expulsion rate of 0%. The district also maintained a middle school dropout rate of 0%. 100% of the certificated staff participated in multiple professional development opportunities.

We have had a significant improvement in the areas of attendance rates and chronic absenteeism. Our attendance rates in 2023-2024 were 84% but has increased to 96% at the end of the P2 attendance collection in April. Attendance improvement strategies included utilizing short-term independent study contracts. The district has hired school van driver, will continue to track daily attendance and communicate with families regarding the importance of regular attendance. New social studies curriculum is needed for sixth through eighth grades. We use teacher created assessments and IXL, because of our small population, we are able to monitor growth in learning. All students made growth this year

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The LCAP was developed using needs assessments and feedback from educational partners. We conducted surveys, asked for community feedback during board meetings as well as sending surveys to students, staff, parents, board members and the LEA's surrounding community members. All staff members, board members, parents and students were surveyed. Community members were invited to take the survey as well. Through this and 1:1 conversations with parents, students and staff, needs were determined and the LCAP was written accordingly. Notable feedback was the need for increased transportation services, literacy improvement, counseling services and a personal supplies closet. We also identified a need for a monthly newsletter and increased communication between school and educational partners. Retention issues were noted for the administrative position, caused by budgetary constraints. We are no longer eligible for equity multiplier funds so Goal 3 will no longer be included in our expenditures although it will remain in our LCAP.

All certificated staff attended professional development opportunities and all students were offered 5+ field trips.

All actions for this goal were successfully implemented. The building was well maintained, and upgrades were made to exterior paint. The playground was improved with the addition of wood chips and cutting the swing set bolts to meet safety standards. We met and exceeded our field trip goals. Transportation for a student attending another LEA as well as transportation to and from field trips. No enrolled students used the van for transportation to and from school on a regular basis. An administrator fulfilled the duties mentioned in Action 2. We provided snacks and occasional lunches, although most of our students bring lunch from home.

We provided a safe environment and made improvements to our playground area, adding wood chips and cutting off protruding bolts on the swings. The building exterior has been 80% repainted. We've had no suspensions, expulsions or dropouts this year. We have less parent involvement, due to our parent/classroom aide moving away this year, but 100% attendance at parent conferences.

G2A5 Provide nutritious snacks to all students during the school day. We provided snacks which helped students to focus and we occasionally provided lunch to students who had forgotten their lunch. Providing snacks was effective in helping students to feel comfortable and able to learn at school.

2/3 of our students are from low income families. 57.1% of of students are chronically absent (CA School Dashboard 2022-23) . 22% of our students do not feel safe or connected to campus. We have retention issues with administrators, only one administrator has stayed > 2 yrs in the past decade. We have declining enrollment and have dropped from 19 students to just 3 students over the past 5 yrs. We want to support a positive climate to improve retention of staff and students. We are no longer eligible for Equity Multiplier funds in the 2025-2026 or the 2026-2027 school years. Additionally, we are closing on 6/30/25 due to lapsation so we will no longer be a school as of 7/1/25.

We were unable to recruit an applicant for the counselor position and it went unfilled. HCOE provided some support at the end of the year to help students transition to their new school setting, due to our lapsation.

While we were able to partially fund our teacher with equity multiplier funds, other needs were not able to be met (see G3A2)due to a lack of applicants for the counselor position. Our current student population did not need clothing and supplies at the level predicted in the spring of 2024.

When our population changed, our needs changed. We were unable to hire a counselor(G3A2). We did use clothing closet and personal supplies money (G3A1) to help support students needing supplies such as gloves, and other equipment needed to safely participate in school projects. As of 7/1/25 our district will be in lapsation, meaning that the school will be closing due to lack of enrollment. We will no longer be eligible for for equity multiplier funds.

Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Total Funds:** This amount is automatically calculated based on amounts entered in the previous four columns.
- **Planned Percentage of Improved Services:** For any action identified as contributing, being provided on a Limited basis to unduplicated students, and that does not have funding associated with the action, enter the planned quality improvement anticipated for the action as a percentage rounded to the nearest hundredth (0.00%). A limited action is an action that only serves foster youth, English learners, and/or low-income students.
 - As noted in the instructions for the Increased or Improved Services section, when identifying a Planned Percentage of Improved Services, the LEA must describe the methodology that it used to determine the contribution of the action towards the proportional percentage. The percentage of improved services for an action corresponds to the amount of LCFF funding that the LEA estimates it would expend to implement the action if it were funded.

For example, an LEA determines that there is a need to analyze data to ensure that instructional aides and expanded learning providers know what targeted supports to provide to students who are foster youth. This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the current LCAP year.

Calculations in the Action Tables

To reduce the duplication of effort of LEAs, the Action Tables include functionality such as pre-population of fields and cells based on the information provided in the Data Entry Table, the Annual Update Summary Table, and the Contributing Actions Table. For transparency, the functionality and calculations used are provided below.

Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
