CSLA program used to exist to increase leadership programs. Dr. Smart and Rosie Slentz have been proving leadership training to superintendent/principals. This is a new grant with a minimum of 1 million dollars per year for 3 years to support the northern region and may be renewed based on funding.

This grant will support the northern region and provide professional development to business managers, teacher leaders, principals and superintendents to help build their capacity in the roles they current hold. 27% of school districts are run by principal/superintendent with limited availability to PD, rural area leaders wear many hats. This grant will expand upon the CRSPA model that the team has been working on for the last 2-3 years

8.2 Superintendent's Report

Dr. Hartley would like to complement the board on their professionalism. The Board is modeling the process by listening to each other and looking for a common resolution and it's nice to have some of our leadership team here to see the process.

Dr. Hartley would like to welcome Melissa Hodgson his new assistant, she comes with 6 years of experience from Eureka City Schools and has an indepth understanding of programs and categorical funding.

The January proposal of the State budget has been released. The original budget was showing an expected COLA increase of 3%, but the proposed budget is showing a COLA

of 2.29%, that is a little under what we expected, it may go up in May. Remember there is a January proposal, a revision in May and then in June it will go to the public for a vote. The 2.29% COLA doesn't cover our cost of doing business with our increase in salaries and the STRS and PERS employee contributions that have been going up. Our costs are closer to 2.35%, with that it doesn't leave a lot of wiggle room.

We would like this budget to focus on special education and gaining access to resources in rural California. Many districts spend more money on special education than is allocated and nearly all are using general funds to cover those costs.

8.3 Draft 2020-21 Calendar

Draft calendars-2

Dr. Hartley stated that he will bring one of the calendar options to the board meeting next month for approval. He is waiting for districts to adopt their calendars in an attempt to align our dates with other districts in which we operate classrooms. The first day of school will be different, but we are trying to align Christmas vacation and Spring Break.

8.4 AJJC Update

Prop 39 moving forward with the MOU to use the facility. They seem to be open to the agreement, but it has not been reviewed at this point.

The other issue is that no SELPA has picked them up for special education services. Currently there are 80 students with an intent to enroll. Once the MOU passes they will have to enroll students. Transportation will not be provided, staff has agreed to stay on with the charter school. The employees will not be unionized and will lose all sick leave and benefits. Enrollment in Southern Humboldt has been flat.

With this charter going forward it will affect the district's enrollment and dollars, they may have to make some cuts. The principal of the high school is out on sick leave and the Superintendent has resigned, but has agreed to stay on until June. They are appreciative of the assistance from HCOE.
