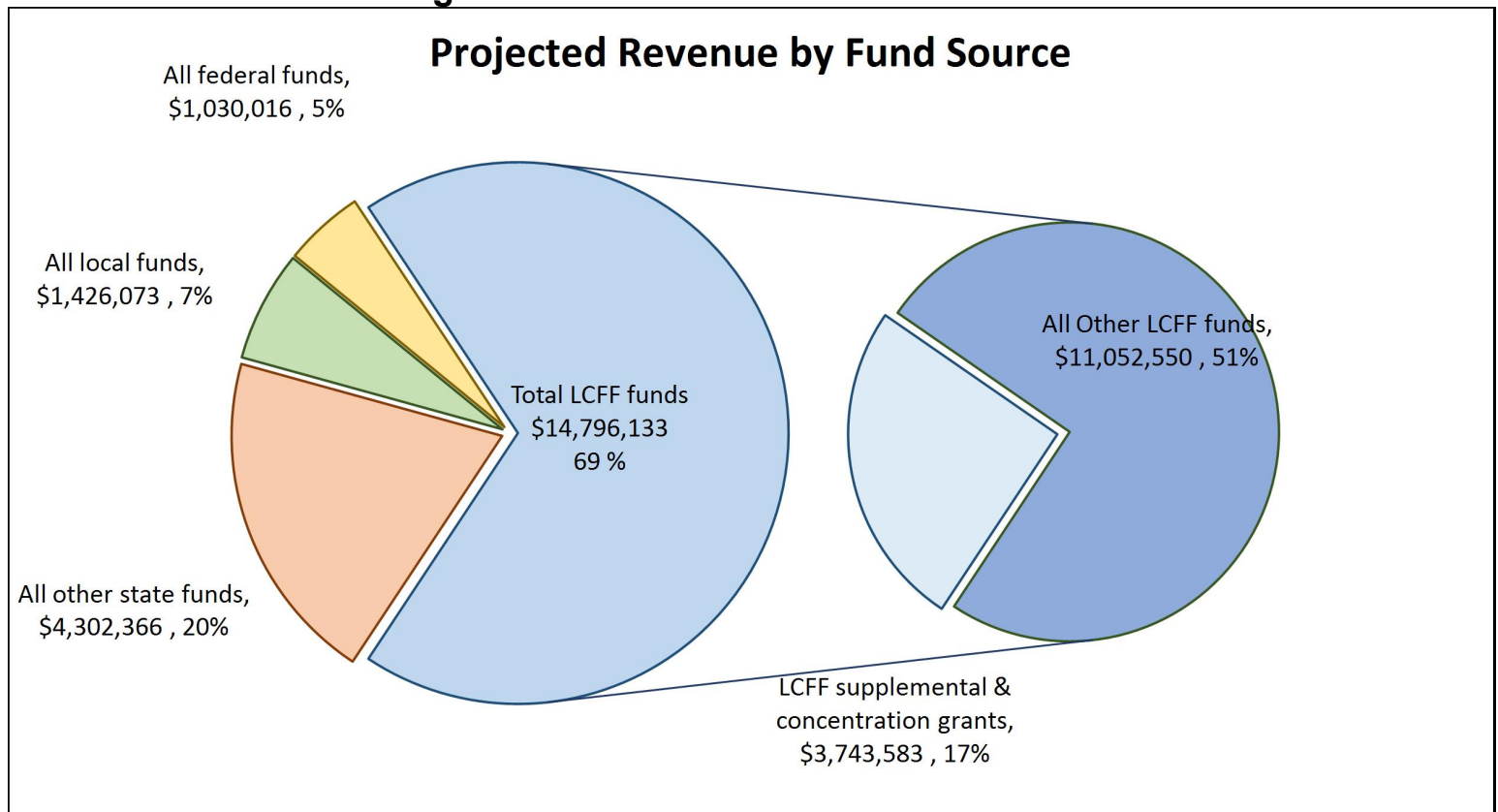

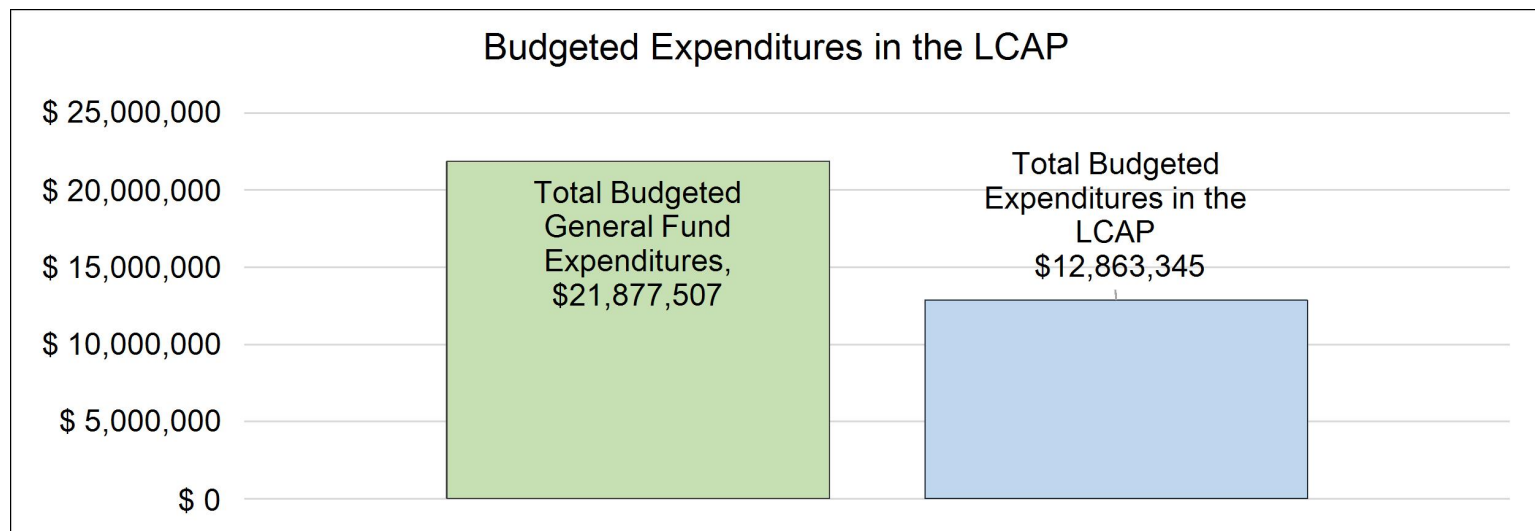


This chart shows the total general purpose revenue Fortuna Elementary School District expects to receive in the coming year from all sources.

Of the \$14,796,133 in LCFF Funds, \$3,743,583 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

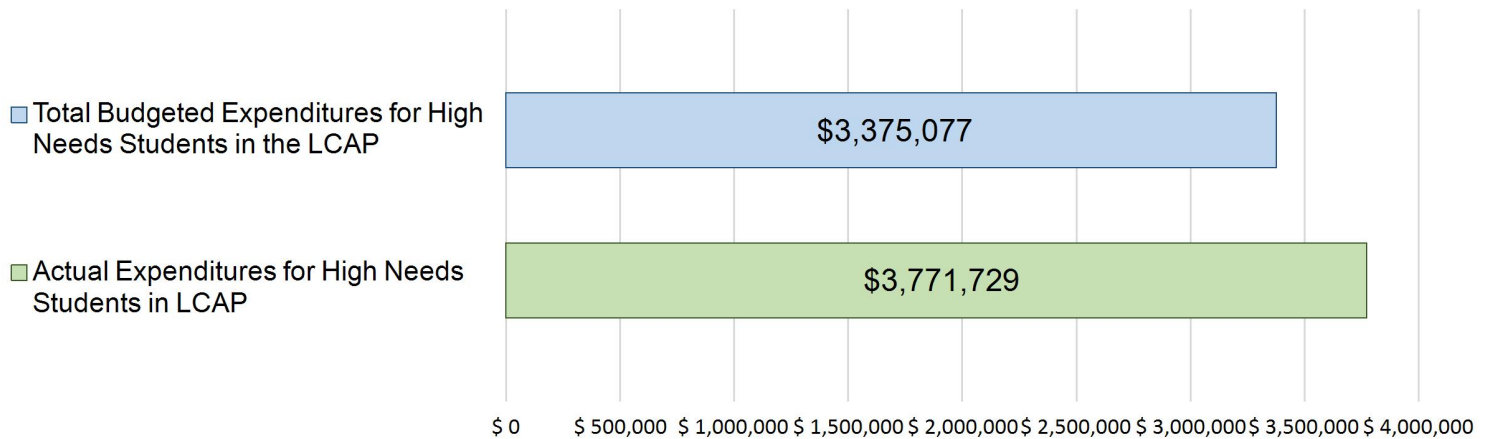
Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

Plan Summary [2025-26]

General Information

The Fortuna Elementary School District (FESD), located in the city of Fortuna in Humboldt County, educates 1005 students ranging from transitional kindergarten through the 8th grade. The students are dispersed across four school sites: Norman G. Ambrosini Elementary, Linell K. Walker Elementary, Toddy Thomas Middle School, and Fortuna Middle School. In order to adapt to the necessities of 21st-century learning and accommodate the diverse abilities within its student body, each student is equipped with a one-to-one electronic device. This determination to promote inclusivity and integrate technology-based learning practices is enhanced by the use of grants and various funding resources. One such resource is the California Community Schools Partnership Program Implementation Grant, which benefits all four schools in the District over a five-year period with an estimated total of five million dollars. Each school within the District offers programs specific to the needs of students with disabilities and English language learners. Additionally, they provide after-school programs, behavior support assistants, and intervention teachers. A concerted effort is made to focus on the students' emotional and social development alongside their academic achievement. This balance is maintained through the services of school site counselors, Climate and Culture Ambassadors, a Restorative Practices Coach, Positive Behavioral Interventions Supports (PBIS), and the implementation of Restorative Circles. The Gifted and Talented Education (GATE) programs further enrich student experiences in both middle schools. Recognizing the uniqueness of each student, FESD strives to provide a comprehensive educational experience for them. This commitment is manifested through a strong music program, spring and winter music concerts, active Associated Student Body groups in both middle schools, after-school enrichment clubs, a Community Schools Grant Coordinator, and a variety of athletic programs at the middle schools. The FESD's persistent dedication to social responsibility, educational excellence, and engaging a diverse community is evident in the District's demographics. The student body consists of diverse socioeconomic backgrounds, with approximately 82% of students qualifying for the free/reduced meal program and a composition that reflects ethnic diversity. This unwavering commitment to inclusivity, diversity, and

community partnership encapsulates FESD's enduring devotion to fostering an environment that nurtures all facets of the young lives under their care in tandem with the demands of 21st-century learning.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Annual Performance Summary (2024 California Dashboard)

In the 2023–2024 academic year, Norman G. Ambrosini Elementary, Linell K. Walker Elementary, Toddy Thomas Middle School, and Fortuna Middle School continued to face challenges in several key areas of student performance. Districtwide, chronic absenteeism and suspension rates remained areas of concern across most student groups. The performance of English Learners (ELs) declined slightly, with only 37.1% making progress in English language proficiency—a 2.7% decrease from the prior year. Academic difficulties in English language arts (ELA) and mathematics persisted for ELs, students with disabilities, and homeless students. Long-term English learners showed particularly significant academic need, performing well below standards in both ELA and math.

Chronic absenteeism improved overall, declining by over 10 percentage points to 17.2%. However, high absenteeism rates remained among American Indian, homeless, and socioeconomically disadvantaged students. Suspension rates increased districtwide to 7.9%, with elevated rates among students identifying as American Indian, White, socioeconomically disadvantaged, or having disabilities. Students identifying with two or more races also continued to experience relatively high suspension rates.

According to CAASPP results, 27.93% of students met or exceeded the standard in ELA, and 19.15% did so in mathematics. While these percentages remained similar to the previous year, student growth scores indicated that most students scored below typical year-to-year growth expectations in both subjects. English Learners scored on average 118 points below standard in math and 87 points below in ELA.

Despite these challenges, there were several bright spots. Chronic absenteeism showed marked improvement due to consistent community outreach and engagement efforts. School counselors, deans, and campus ambassadors continued to provide essential support through Restorative Practices, mediation, and student-centered intervention models. Empathy interviews conducted with students helped foster stronger relationships with adults on campus, while implementation of PBIS strategies reinforced positive behavior and student recognition. These initiatives collectively contributed to an increase in students' feelings of safety and connection at school.

Parent engagement remained a focus area. Although some gains were made through school events and advisory meetings, participation in districtwide surveys was still limited. Moving forward, efforts will prioritize more inclusive outreach, better communication strategies, and a stronger emphasis on elevating student and family voices in decision-making.

Overall, the District remains committed to continuous improvement through targeted academic support, restorative discipline practices, culturally responsive family engagement, and data-driven resource allocation.

Reflections: Technical Assistance

The 2024 California School Dashboard identifies Fortuna Elementary School District (FESD) as continuing to meet the eligibility criteria for Differentiated Assistance (DA), including sustained eligibility for deeper support under Education Code 52072 due to persistent performance issues among three or more student subgroups across three of the last four years. FESD has been identified by the California Collaborative for Educational Excellence (CCEE) as needing continued technical assistance, with the primary focus placed on the needs of its most vulnerable students.

According to the 2024 Dashboard, four student groups within FESD—English Learners, Long-Term English Learners, Socioeconomically Disadvantaged students, and Students with Disabilities—showed consistently low or very low performance across key priority areas, including Pupil Achievement, Pupil Engagement, and School Climate. Specifically:

English Learners and Long-Term English Learners were identified for very low achievement in both English language arts and mathematics, very low progress in English language proficiency, and high rates of chronic absenteeism.

Socioeconomically Disadvantaged students showed very low performance in math, elevated chronic absenteeism, and increased suspensions.

Students with Disabilities continued to underperform in both English language arts and mathematics, in addition to struggling with chronic absenteeism and high suspension rates.

In response, the District continues to implement multiple actions aligned to its goals and the identified priority areas:

Academic Achievement (Priority 4): District actions (G1A1, G1A2, G1A3, G1A4, G1A5, G1A6, G1A7, G1A8, G1A9, G1A10, G1A11) include maintaining intervention teachers at each school site, investing in evidence-based curriculum pilots, providing targeted support for English learners, and strengthening inclusion models for students with disabilities.

Pupil Engagement (Priority 5): To address high rates of chronic absenteeism (G2A1, G2A3, G2A4, G2A5, G2A7, G2A8, G2A9, G2A10, G2A12, G2A13), the District continues outreach efforts, including parent messaging campaigns, School Attendance Review Team meetings, empathy interviews, and intensive coordination through the School Attendance Review Board (SARB).

School Climate (Priority 6): The District's Restorative Practices framework, implementation of Positive Behavioral Interventions and Supports (PBIS), site-based counseling, and wellness room development (G2A1, G2A3, G2A4, G2A5, G2A6, G2A7, G2A8, G2A10, G2A13) have been key strategies to reduce suspensions and build a more inclusive, connected school culture.

FESD will continue to work closely with the Humboldt County Office of Education and the California Collaborative for Educational Excellence to deepen its analysis of root causes, evaluate the effectiveness of current initiatives, and apply high-impact, data-informed interventions.

The District's involvement in Differentiated Assistance reinforces its commitment to addressing longstanding equity gaps, ensuring every student has access to high-quality educational opportunities and a safe, supportive school environment.

As part of our technical assistance efforts, the District has partnered with Studer Education to develop a comprehensive five-year Strategic Plan. This collaboration will help align our goals, actions, and accountability systems with stakeholder priorities and long-term student success.

The 2023 Dashboard reveals that the Fortuna Elementary School District continues to meet the eligibility criteria for Differentiated Assistance (DA). However, the composition of the identified student groups and areas of eligibility have undergone changes. Presently, the District houses four eligible student groups in varying priority areas. These groups include English learners, white students, socioeconomically disadvantaged students, and students with disabilities. Each group is known to face distinct challenges, such as chronic absenteeism, academic struggles, and suspensions. Efforts in the form of technical assistance have been initiated within the District to address these areas of concern. A campaign targeting parents is currently being implemented to emphasize the significance of regular attendance. School Attendance Review Team meetings are organized for students at risk of chronic absenteeism. In order to consolidate these efforts, a School Attendance Review Board process is being utilized. Suspension rates are being targeted by implementing Restorative Practices, while new pilot programs focusing on math initiatives are being tested to improve math scores. The District has intervention teachers at each site to address the learning loss in both English language arts and mathematics. Inclusion programs are being executed, while English Language Development teachers have been assigned to each school site.

Priority 4 (Pupil Achievement) uses assessments such as CAASPP and STAR to measure and enhance students' mastery of the curriculum. Priority 7 (Course Access) ensures all students have access to a broad course of study, including essential subjects like art, music, science, social studies/history, and physical education. This comprehensive approach was methodically developed using data-driven decisions and stakeholder collaboration to address equity, resource alignment, and professional learning across all priorities.

Action 1.5 – Counselors and School Psychologists

Salaries and benefits came in below budget because new hires were at entry-level pay, resulting in lower overall costs than originally projected.

Action 1.6 – Expanded Learning Opportunities (ELOP)

In order to meet the spending deadline, ELOP costs exceeded the original estimate. Those additional funds were redirected toward ELOP building maintenance and transportation.

Action 1.7 - Professional Development

The district chose to prioritize employee development by allocating more funds to professional development than initially budgeted

Action 1.8 – Technology Staffing

The district incorporated a car allowance into the Technology Director's compensation package. However, this item came in less than originally budgeted due to a clerical error in the original amount listed.

Action 1.9 – Technology Devices

The District purchased more Chromebooks than anticipated, causing actual device expenditures to exceed the original budget.

Action 1.10 – Instructional Materials

The need for new instructional materials was lower than expected, resulting in actual expenditures coming in below the budgeted amount.

Action 1.11 – Class Size Reduction

Although enrollment is declining and average class sizes are lower, overall costs have increased. This is due to structural and policy-driven factors, including contractual obligations and the need to maintain staffing levels for specialized programs. Salaries and benefits remain the largest portion of the budget and are not easily reduced in response to declining enrollment.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Action 1.3 – Instructional Assistants

Partially effective: While instructional assistants provided small-group academic support, overall academic gains were minimal. CAASPP scores showed little improvement, and English Learner reclassification rates remained low.

Action 1.4 – EL and Intervention Teachers

Partially effective: Targeted support was provided to English Learners and struggling students, but progress remained limited. ELPI growth and reclassification outcomes did not meet targets, suggesting limited impact in Year 1.

Action 1.5 – Counselors and School Psychologists

Somewhat effective: This action supported student well-being and engagement, which may have contributed to improved attendance and school climate. Direct academic impact was limited.

Action 1.11 – Class Size Reduction

Potentially effective: Maintaining lower class sizes supported instructional access, but CAASPP performance data showed minimal gains, indicating limited academic progress despite smaller class environments.

Action 2.5 – District/School Communications

The District expanded its use of ParentSquare by adding new services to improve communication with families, leading to higher-than-expected costs.

Action 2.9 – Transportation

The District's transportation contract increased by 10% compared to the previous year, which raised actual expenditures beyond the original budget projection.

Action 2.11 – Translation Services

Because a new EL curriculum was purchased in the previous year, fewer related expenses were necessary in the current year, resulting in lower actual costs.

Action 2.12 - Nutrition Services

In order to avoid increasing the ending fund balance in the Child Nutrition resource, the contribution was reduced."

Action 2.13 – Positive Academic and Behavior Recognition

To enhance the program's effectiveness and expand recognition efforts, additional investments were made this year beyond initial projections, resulting in higher-than-budgeted expenditures that support stronger student engagement and positive behavior outcomes.

Action 2.1 – Music Teachers

Likely effective: Increased student engagement through music instruction likely contributed to improved average daily attendance. Positive climate outcomes are also associated with access to arts education.

Action 2.3 – Counselors and School Psychologists

Effective: Behavioral and emotional support services contributed to a stronger sense of student connection and may have positively influenced attendance and reduced behavioral incidents.

Action 2.9 – Transportation

Effective: Improved access to school via transportation services supported notable gains in average daily attendance and reduced chronic absenteeism.

Action 2.10 – Family Resource Center

Moderately effective: The center provided support to families that may have enhanced student well-being and attendance. However, increases in parent engagement were minimal.

Action 2.11 – Translation Services

Moderately effective: Written and verbal translations are consistently available to families, ensuring that key information is accessible to non-English-speaking parents. While this support is in place, overall parent engagement among non-English-speaking families remains an area needing improvement, indicating that translation access alone has not fully bridged participation gaps.

Action 2.12 – Nutrition Services

Effective: The provision of free breakfast and lunch supported attendance and student readiness to learn. It likely contributed to gains in ADA and positive student perceptions captured in survey data.

 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
