6.4 Accept Funding of Teacher Residency Grant from California Commission on Teacher Credentialing

Heidi Moore-Guynup states that this grant funding will support 11 individuals to obtain their special education credential by assisting with costs associated with university credits costs, books, materials and related assessment costs. The funding also supports stipends for 11 master/mentor teachers to provide guidance and support during the fieldwork portion of the credential program. She shared the flyers that went out to describe the program to both districts and teacher candidates. The districts will agree to hire the teacher for the 2019-20

year with a commitment to offer ongoing employment for four years. The candidate commits to the four years as well. Candidates must have a bachelor's degree and the program is targeted towards classified employees working in the districts currently. The program allows a candidate to continue working and complete the program in evenings and weekends. Having received this grant makes HCOE eligible for renewal, at which point we can continue with a special education path or change to a single or multiple subject, as the need presents.

Dr. Hartley acknowledged the superintendents and Mindy Fattig who attended the second Humboldt legislative action day with him in Sacramento. He stated there was a drastic change in those they met with from the year prior in that they remembered them and the information

they shared about Humboldt. Governor Newsom has not made major changes to staffers, so they were able to meet again with the Chief Consultant to California Assembly Education Committee, the Chief Operating Officer of the Department of Finance, as well as 6 others.

Dr. Hartley acknowledged the work of Stephanie Jackson and Marika Myrick from the Personnel Department who worked in partnership with HSU on the recent job fair. The special education credential students were well represented. Many of our local districts as well as some from other areas of California and as far away as Nampa, Idaho, were tabled at the event.

Dr. Hartley announced that we are well into "Award Season". Four-hundred students participated in the All-County Music Festival, the Spelling Bee took place, 500 students participated in History Day, and 300 in the Science Fair. As mentioned, the Academic Achievement Event went well and Dr. Hartley thanked Mary Scott and President Eckenrode for attending and for their participation on the interview panel. Dr. Hartley also acknowledged local service organizations who donate to make these events possible. He additionally acknowledged staff and event coordinators who make these events a success due to their dedication and attention to detail. He stated his sincere appreciation to the team at the county office and our district partners.

8.0 HUMBOLDT COUNTY CLASSIFIED EMPLOYEE OF THE YEAR RECOGNITION

Dr. Hartley stated that, with the encouragement from Monica Dekat and President Eckenrode, he promoted the Humboldt Classified Employee of the Year recognition by reaching out to districts for nominations. From those nominations, six people were selected, one from each category, to go on to be considered for the State recognition.
