#### 7.1 Superintendent's and COVID-19 Report

Dr. Hartley announced that Corey Weber has accepted the position of HCOE Assistant Superintendent of Business. This position has been vacant for a number of years. It was important for HCOE's fiscal department to look at what kind of support our districts need. With Corey as the Fiscal Director, there have been some gaps in service. Corey will do an outstanding job and is excited about being able to support our districts in all aspects of their fiscal management and responsibilities.

The Governor's proposal projects increased revenues. Current year deferrals were not mentioned, but there is a proposal to pay down deferrals for '21-'22 until June 2022. We are advocating for current year deferrals. There is a proposed COLA increase and increased funding for Special Education.

HCOE programs will be going back to their hybrid model on January 19th. We went back to distance learning after Thanksgiving break, based on a recommendation from Public Health regarding travel. We applied the same concept to the Winter Break. There continues to be no confirmed cases of secondary transmission in Humboldt County.

HCOE continues to work with Public Health to assist in vaccination planning for all of our educators. As well as other options for COVID testing.
