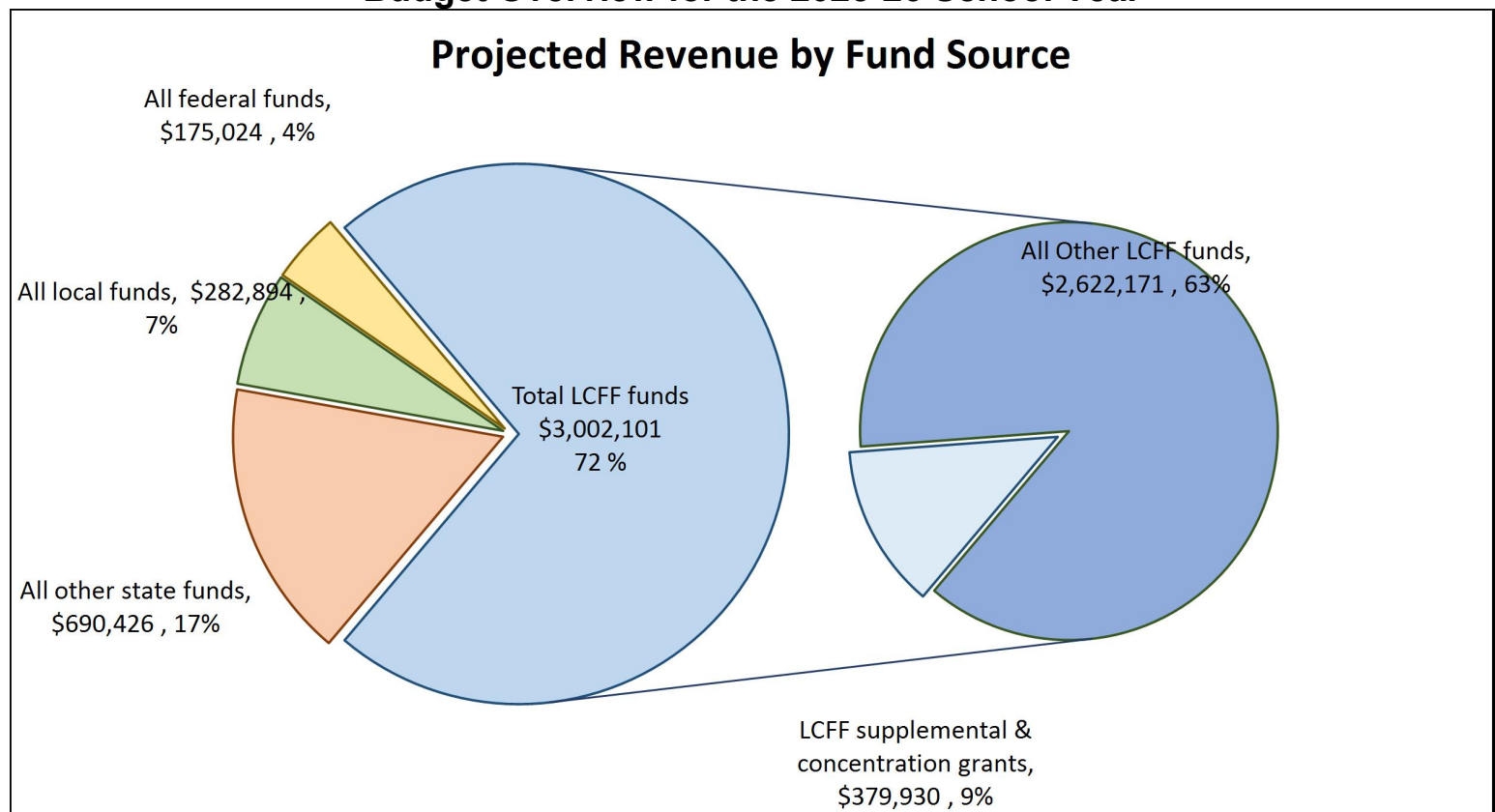

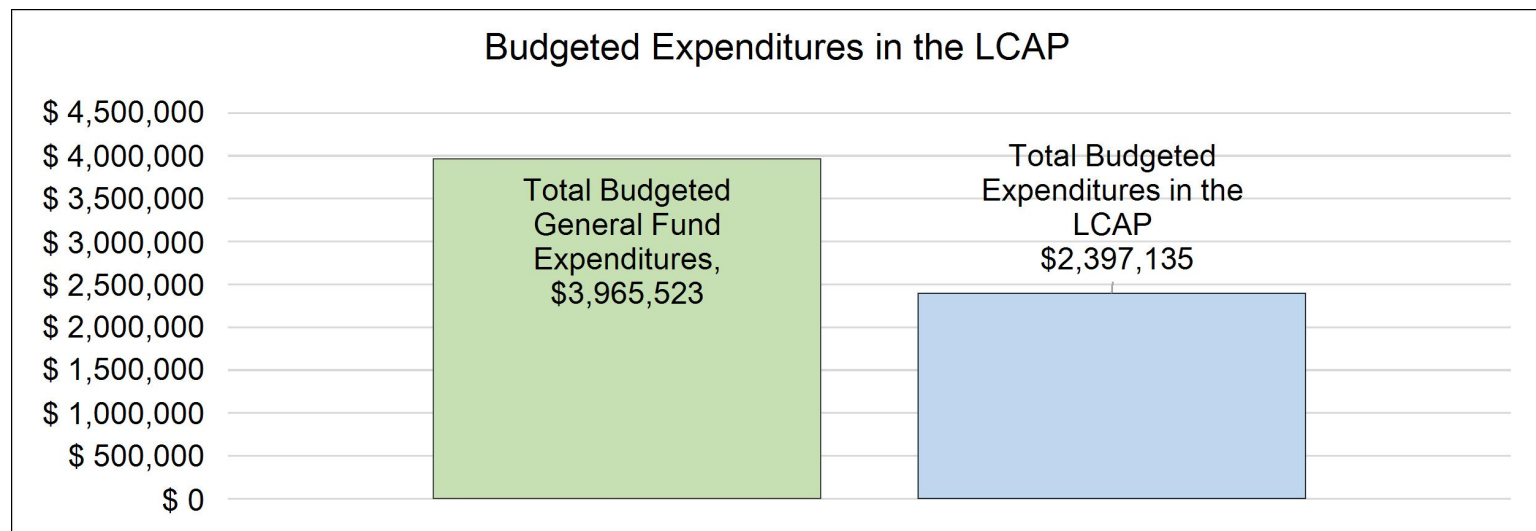


This chart shows the total general purpose revenue Coastal Grove Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Coastal Grove Charter School is \$4,150,445, of which \$3,002,101 is Local Control Funding Formula (LCFF), \$690,426 is other state funds, \$282,894 is local funds, and \$175,024 is federal funds. Of the \$3,002,101 in LCFF Funds, \$379,930 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

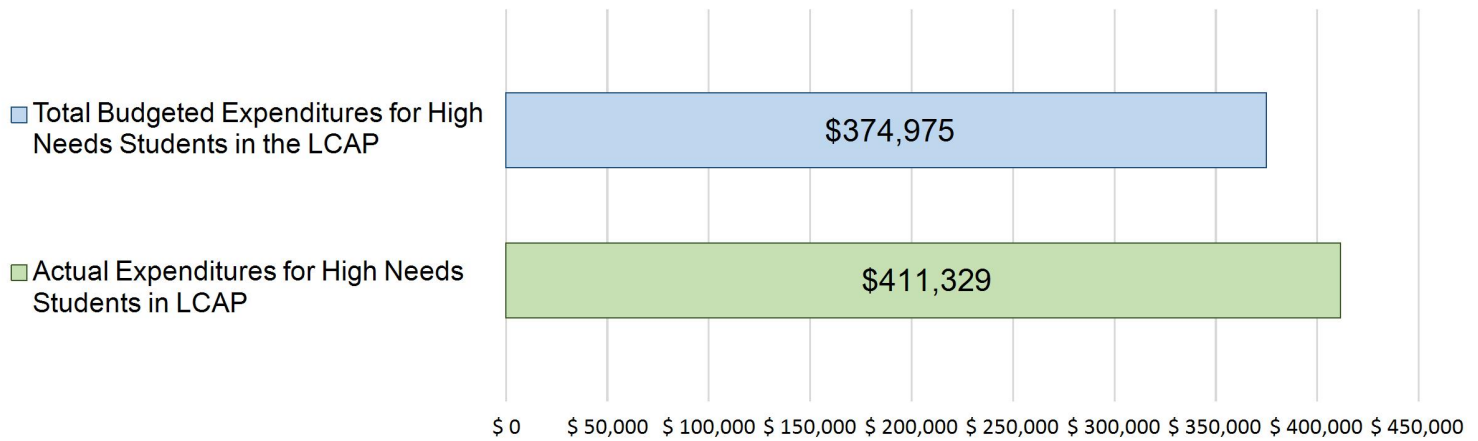

General Information

Coastal Grove Charter School, a California nonprofit public benefit corporation with 501(c)(3) tax-exempt status, is authorized by Arcata Elementary School District. We have approximately 239 students and our free and reduced-price meal percentage is approximately 56%. The school offers an integrated method of Waldorf education which fosters a life-long love of learning by educating the whole child: head, heart and hands. By challenging the head, inspiring the heart, and motivating the hands, the school educates children in a K-8 setting. We offer a classroom-based and homeschool program. Our small group setting enriches the imagination, creativity, academic excellence, and social responsibility. Educated students will emerge capable of self-expression, effective communication, problem solving and critical thinking, and with a global consciousness and ability to succeed amidst the challenges of our changing world. This integrated approach balances artistic, academic, and practical work to foster a life-long love of learning. Following the metrics is not applicable because we are a K-8 school with no EL students this year, and we do not have a high school. Here at Coastal Grove we believe that all students can achieve their fullest potential through a supportive and a strong school community that works together with families. Coastal Grove is in a strong position to continue meeting our goals as we prepare Coastal Grove students for success.

Reflections: Annual Performance

For 23/24 we saw improvements in each of these areas on the Dashboard. Successes include a 12.5 % improvement in attendance, a 3.6%

drop in suspensions, a 15.1 point increase in English Language Arts scores and a 33.7 point increase in Math scores. There were fewer behavioral referrals to the office.

Our annual parent survey is distributed every spring. It is attached to our weekly newsletter, The Friday Flyer and distributed at the spring All Parent Class Meeting. The Friday Flyer goes out via email. It is also available in hard copy in the office. An LCAP survey was distributed to parents to gather creative comments and ideas. This year LCAP input was gathered through parent and staff surveys and student surveys, parent conferences and parent class meetings, one on one meetings both in person as well as zoom meetings, EDI meetings and observations. As a result of the survey input, we have continued to employ instructional aides, continued to support Waldorf methods staff development, and continued experiential field trips.

We focused on improving instruction through professional development, teacher training, collaboration and mentoring support. The professional development has made a significant improvement in student success. Public Waldorf training has become costly. We are currently implementing training during our weekly meetings with qualified guest instructors. We also had 5 teachers participate in Orton-Gillingham training which has helped realize significant improvement in reading as reported through assessment and portfolio work. DIBELS assessments have helped teachers target instruction and assess needs in a more comprehensive manner. We purchased supplemental Language Arts materials to support reading instruction. We tried a new math curriculum but felt it is not as useful, and with the new framework, we are reevaluating for the 25-26 school year.

Coastal Grove is a Waldorf inspired public school with significant values geared towards academic as well as other forms of enrichment. This goal was developed with our educational partners in response to feedback through surveys and an identified need for student and staff sense of safety and connectedness based on state and local data including surveys, absenteeism, and suspension rates. We conducted a root cause analysis to determine the causes of higher rates of chronic absenteeism and suspension. Lack of school connectedness and high levels of reported anxiety resulted in high absenteeism, while a lack of consistent supports and unequal application of restorative practices was a leading cause of increased suspension rates. Families suggested we expand our counseling programs and offer continuing professional development in both public Waldorf education and restorative practices for all staff.
