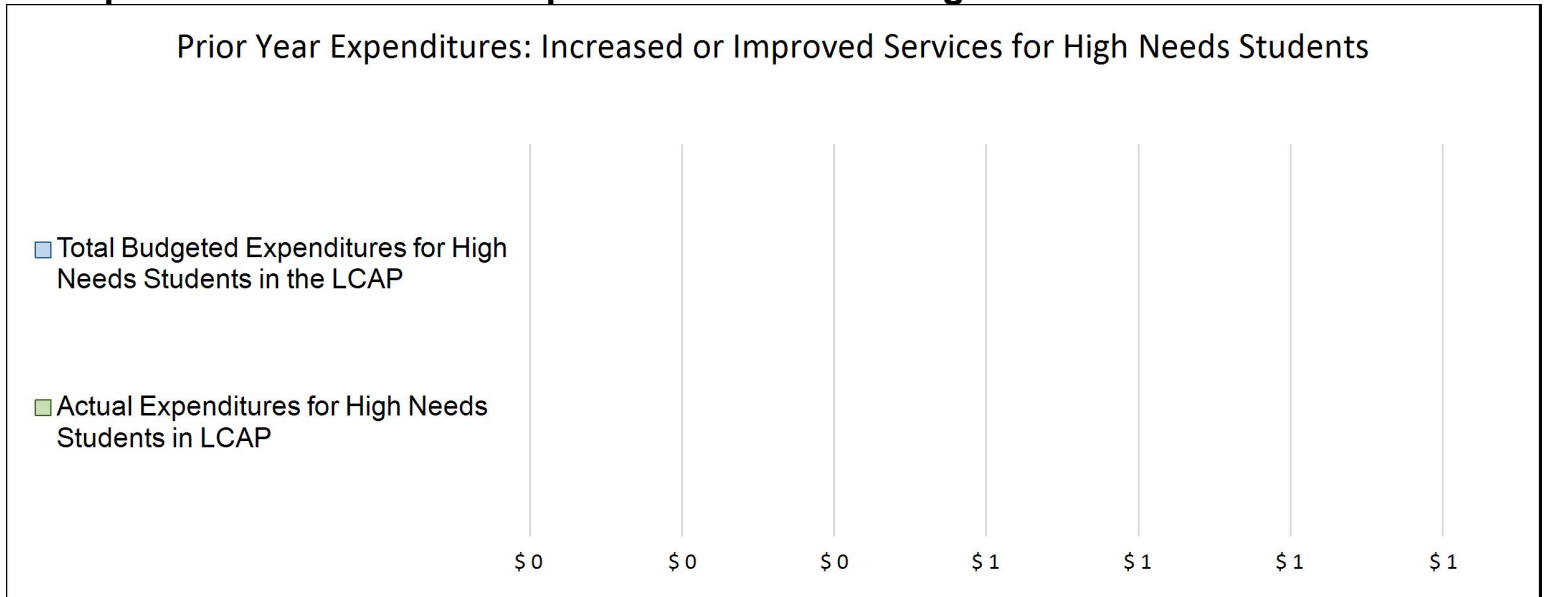

General Information

Perched on a bluff overlooking Humboldt Bay and the Pacific Ocean beyond, Pine Hill Elementary School serves approximately 220 students ranging from transitional kindergarten through third grade. It is part of the South Bay Union Elementary School District. The school is located on the coast about 280 miles north of San Francisco and just south of Eureka, a city with a population of 27,000. It is one of two schools in the South Bay Union School District. The other school, South Bay Elementary School, is a 4-8 grade school. Our students in 7th and 8th grade are part of our on campus charter school. Our charter school also serves many students through an independent study program. Students live in the Elk River Valley, Pine Hill, Humboldt Hill, King Salmon, and Fields Landing neighborhoods that range from economically disadvantaged to upper-middle-class single family dwellings.

We foster positive connections with all students that encourage them to embrace learning, achieve independence, and know that they can succeed.

Summary: While ELA performance and absenteeism improved notably, math scores declined and suspension rates increased, highlighting a need for targeted behavioral supports and math interventions.

ELA Performance: 142.6 points below standard (Declined by 65 points)
Math Performance: 169.5 points below standard (Declined by 64 points)

Summary: Despite a marginal improvement in attendance, students with disabilities experienced steep declines in both ELA and math performance and a major spike in suspensions. These trends strongly indicate a need for urgent and comprehensive academic, behavioral, and inclusion supports.

During the 22-23 school year, parents, classified staff, and certificated staff participated in focus group sessions during the first month of school. Our educational partners provided more than 1000 data points for our steering committee to analyze to develop our new strategic plan, including updates to this LCAP. Our partners were again surveyed to provide input in February and May. Site Council meetings were held to gather input and feedback four times during the school year. Pine Hill, South Bay, and South Bay Charter site councils reviewed LCAP goals and developed their site plans for student achievement (SPSA) around the LCAP goals. Parents and staff were invited to participate in the meetings and assist with the development of the SPSA at each site. Informal meetings were held monthly with local collective bargaining units to gather input on schoolwide plans for program improvement. The District English Learner Advisory Committee met throughout the school year and provided input regarding the educational program and community needs. Consultation with SELPA provided guidance on support systems for students with exceptional needs.

During the 23-24 school year, we continued this work by holding multiple focus group sessions for parents and community partners. At these meetings, we reviewed the work done in 22-23 and share the district's strategic plan outlining our goals and strategies for the coming years. We received feedback from during the focus groups indicating that the strategic plan captured the needs and wishes of the community and parents. We have surveyed families, staff and students. We used this data to guide our goals in professional development and safe and responsive school environments. Our EL Parent focus group met and provided ideas about cultural activities on campus and other family engagement ideas. Our administrative team meets weekly and our bargaining units meet with site and district leadership.

During the 24-25 school year, we continued this work by holding multiple focus group sessions for parents and community partners. At these meetings, we reviewed the work done in 23-24 and share the district's strategic plan outlining our goals and strategies for the coming years. We received feedback from during the focus groups indicating that the strategic plan captured the needs and wishes of the community and parents. We have surveyed families, staff and students. We used this data to guide our goals in professional development and safe and responsive school environments. Our Native American Parent focus group met 3 times and provided ideas about cultural activities on

campus and other family engagement ideas. Our administrative team meets weekly and our bargaining units meet with site and district leadership monthly. We are active in SELPA Policy Council and maintain attendance at regional and state meetings.

1.1 High Quality Instruction: Our anticipated expenditures for this action were slightly higher than the actual expenses. Our expenditures on curriculum in came less anticipated.

- 1.3 Personalized Interventions: We spent more on this action item than anticipated. We added a position to support our English Language Learners using the funds we did not expend on other action items.
- 1.4 Enrichment: Expenses were less than expected for this action item. We had a healthy inventory of art supplies from previous years.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The implementation of Goal 1 at South Bay Charter Middle School showed mixed effectiveness across its five strategic actions. Action 1.1 (High-Quality Instruction) faced a slight decline in the percentage of appropriately assigned teachers (from 79.3% to 75%), suggesting challenges in staffing despite maintaining access to instructional materials and facilities. In contrast, Action 1.2 (Professional Collaboration) was effective, as evidenced by the full implementation of academic content standards, including for English learners, reflecting progress from initial implementation the year prior. Action 1.3 (Personalized Intervention) had uneven outcomes: while socioeconomically disadvantaged students made substantial gains in both ELA (from 38 to 23 points below standard) and math (from 49.7 to 23 points below standard), students with disabilities experienced a sharp decline—particularly in ELA (dropping to 142.6 points below standard). Action 1.4 (Enrichment) did not show clear academic improvement; science scores fell for all students, especially socioeconomically disadvantaged students, who dropped from 28.57% to 13.64% meeting or exceeding standards. Action 1.5 (Extended Learning) appears to have supported moderate progress, with growth percentiles in both STAR Reading (70.2%) and Math (73.5%), although targets have not yet been met. In sum, while instructional quality and collaboration have strengthened foundational elements, intervention and enrichment strategies need refinement—particularly to better serve students with disabilities and improve outcomes in science.

2.1 Systems of Support: Actual expenditure for this action item, came in much higher than budgeted. This is mostly due to a miscoding of positions during the budget adoption process.

2.2 Social-Emotional and Behavior Supports: We were able to use grant dollars to support this action item resulting in less expenditures than anticipated while still delivering the same services.

2.3 Collaborative Partnerships: Expenditures in this area were lower than expected.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The implementation of Goal 2 at South Bay Charter Middle School reflects meaningful progress in building supportive environments for students, particularly through expanded systems of care and proactive student supports. Action 2.1 (Systems of Support) has contributed to a stable foundation, with student discipline referrals improving and expulsion rates remaining at zero. While average daily attendance declined slightly, the school continues to maintain a relatively strong attendance rate, with efforts underway to reengage students more consistently. Action 2.2 (Social-Emotional and Behavioral Supports) has shown strong results in reducing chronic absenteeism across all student groups, including a notable improvement among socioeconomically disadvantaged students, whose rate dropped from 22.6% to 12.1%. These improvements reflect the success of trauma-informed approaches and counseling services in fostering greater connection to school. Although suspension rates increased, especially for students with disabilities, this presents an opportunity to refine and deepen the implementation of restorative practices and individualized behavioral support strategies. Action 2.3 (Collaborative Partnerships) has strengthened school-community connections and supported students' well-being, as evidenced by generally stable or improving student perceptions of care and safety. Many students continue to feel that adults on campus care about them and make efforts to connect, setting a strong foundation for continued growth in student voice and engagement. Overall, these actions demonstrate a commitment to whole-child support and provide a solid framework for continued progress in school climate, student connection, and equity.

The implementation of Goal 3, focused on family engagement, has shown positive progress in building stronger, more responsive connections between the school and families. Action 3.1 (Two-Way Communication) was effective, as reflected by an increase in parent portal usage—from 25% in 2023–24 to 37% in 2024–25—indicating growth in digital communication and family access to student information. Action 3.2 (Family Involvement) also demonstrated success; parents reported attending an average of seven school events during the year, suggesting that schools are offering a range of meaningful opportunities for families to participate in the school community. Action 3.3 (Family Needs) is being implemented through the Family Resource Center, counselors, and interns, which has helped the district better support and connect families with resources. Collectively, these efforts are contributing to improved relationships, communication, and participation, laying a strong foundation for achieving deeper family-school partnerships aligned to student success.

This is the percentage by which services for unduplicated pupils must be increased or improved as compared to the services provided to all students in the coming LCAP year.
- **LCFF Carryover — Percentage:** Specify the LCFF Carryover — Percentage identified in the LCFF Carryover Table from the prior LCAP year. If a carryover percentage is not identified in the LCFF Carryover Table, specify a percentage of zero (0.00%).

- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
