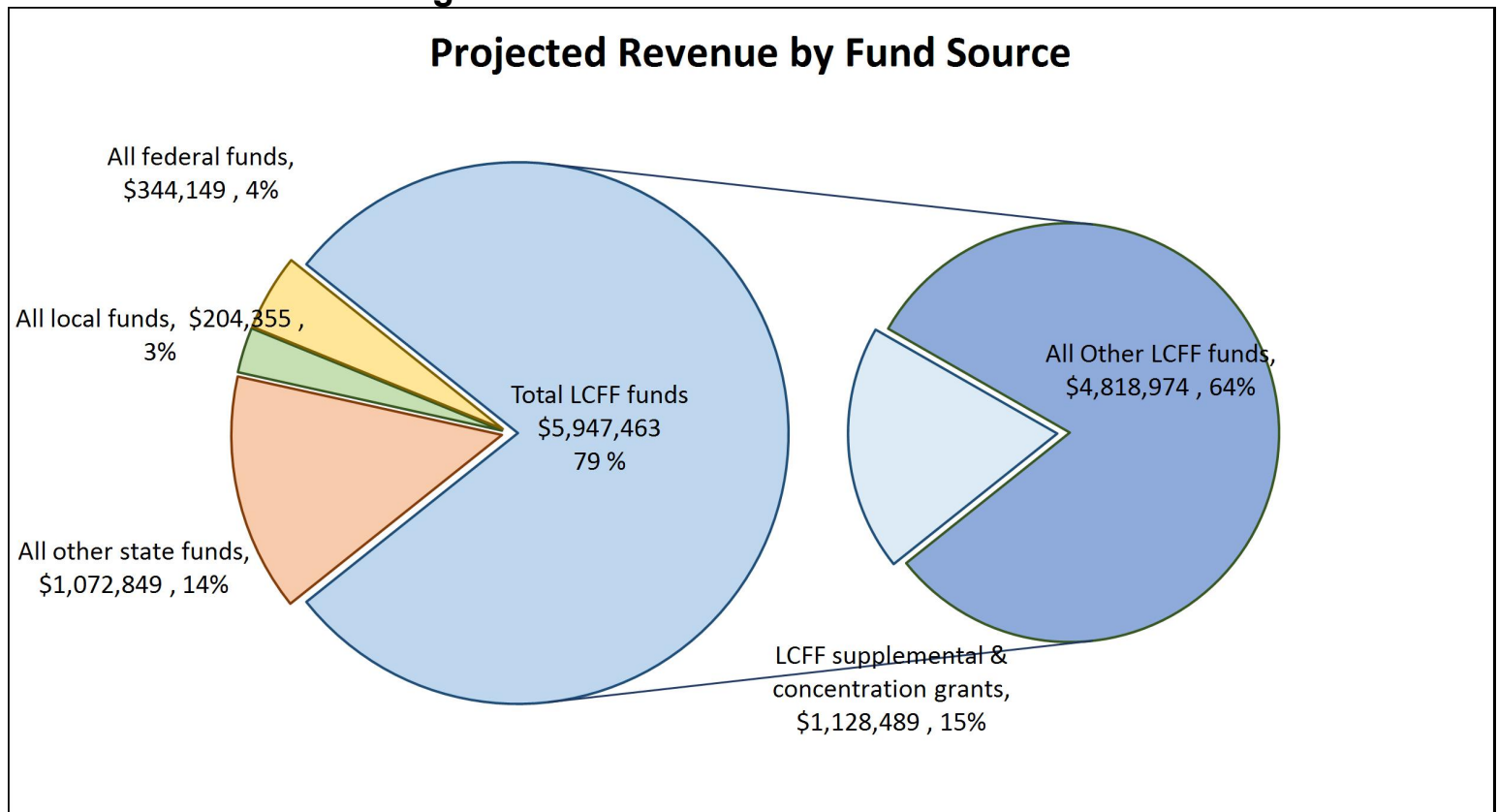

Budget Overview for the 2025-26 School Year

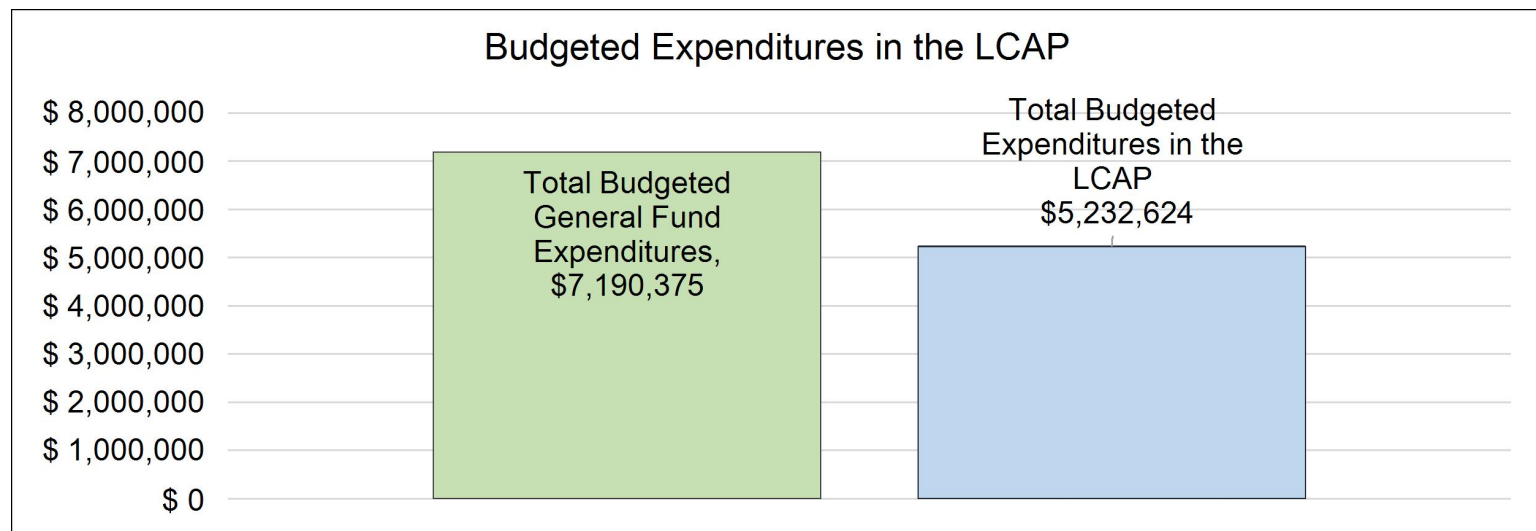


This chart shows the total general purpose revenue Alder Grove Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Alder Grove Charter School is \$7,568,816, of which \$5,947,463 is Local Control Funding Formula (LCFF), \$1,072,849 is other state funds, \$204,355 is local funds, and \$344,149 is federal funds. Of the \$5,947,463 in LCFF Funds, \$1,128,489 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

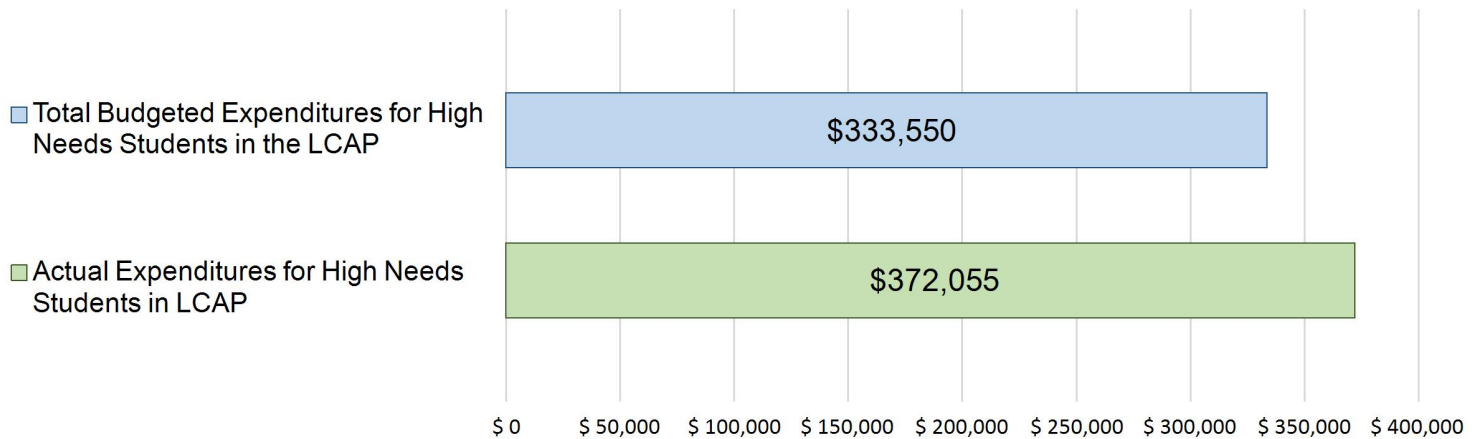
In 2025-26, Alder Grove Charter School is projecting it will receive \$1,128,489 based on the enrollment of foster youth, English learner, and low-income students. Alder Grove Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Alder Grove Charter School plans to spend \$122,370 towards meeting this requirement, as described in the LCAP.

AGCS will continue to use increased supplemental and concentration grant funds for salaries and materials to offer academic support services for foster youth, English learners, and low-income students, as well as all students in need. The school will continue to increase Reading and Writing Support, as well as Math.

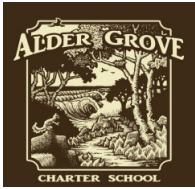
Update on Increased or Improved Services for High Needs Students in 2024-25

Our commitment is to deliver personalized learning through strong family, educator, and community partnerships that empower students to achieve academic excellence and foster active citizenship. It is a partnership between the school, the community, students, and families. Students are provided with curricula materials, technology, parent/guardian support, and academic and enrichment opportunities as well as a credentialed teacher to facilitate student learning. Students blend independent study, classes on campus, home-schooling, online learning, community partners, career technical education, and concurrent/dual enrollment in college to meet their educational goals and prepare for post-secondary life.

Alder Grove's strengths continue in the areas of Chronic Absenteeism (.3%), Suspension Rate (0%), Graduation Rate (94%). Alder Grove is showing strength in it's College and Career department (49% prepared). The school increased 3.4 points in English Language Arts and increased 24.7 points in Mathematics for our best math gain ever. Targeted one-on-one and small group tutoring and in person/online test prep classes are helping students access difficult subjects. The school has also started offering incentives for students who show growth in their scores.

Students with Disabilities showed the biggest growth level for Mathematics and increased by 28 points. One-on-one test preparation with their Education Specialist, online test prep courses, and familiarity with the test are contributing factors.

2.3 CAASPP scores for special education students were "Red" on the dashboard for Math and "Yellow" for English/Language Arts. A 20% increase in mental health crises was documented by the School Psychologist as well as increased "high risk" students using the mental health screener.

Additional Concentration Grant Funding

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

AGCS will continue to use increased supplemental and concentration grant funds for salaries and materials to offer academic support services for foster youth, English learners, and low-income students, as well as all students in need. The school will increase Reading and Writing Support teachers as needed. More time can be added if needed based on enrollment. All students in grades 3 and up who score low on schoolwide writing assessments are required to participate in one hour a week or more of structured Reading or Writing Support. Math support in the form of online programs, tutors, and small group classes are also mandated for students with low scores. The math support program combines 4 certificated math teachers and 4 non-credentialed tutors equaling approximately 6 FTE in total. Writing support is offered in small group instruction and writing labs for students who demonstrate need on schoolwide writing samples equaling .8 FTE. Salaries for teachers to offer daily math lab support for all students, especially benefiting students with less parental support at home, and one on one math and reading tutors for students who are best served by this method. Chromebooks and hotspots will be issued to increase access to education for foster youth and low income students, and all students as needed. Mental health services were provided through a partnership with Humboldt Independent Practitioners Association, as well as a full-time School Psychologist, a full-time School Psychologist intern, and two part time Social Work interns.
