# MINUTES June 12, 2019

Mary Scott commented that the Battle of the Book event was wonderful and that there was great parent involvement. She also thanked Superintendent Hartley for coming to the Retired Teachers' Luncheon to say a few words. President Eckenrode commented on another great Innovate! event.

## **5.0 PRESENTATION:** Health Career Exploration Project – Susi Huschle & Sara Dixon

Susi Huschle shared her pride in the Health Career Exploration Project that got underway 18 months ago and is now in 4 comprehensive high schools, 3 charter programs and the court/community schools. This is part of the Health Exploration project, which is a partnership with industry partners and the Workforce Development Board. Susi introduced Sara Dixon, the instructor at Fortuna High, and shared how Sara designed the program from the ground up including creating the curriculum. Sara stated that she saw a need for and built in a mental health component in their program. County Public Health coordinates the local Directing Change video competition. Megan Montgomery, Health Education Specialist at Public Heath came out to give them ideas and strategies for their films. Two students from Sara's class were present to speak about their experience around the class and their videos. The first video shown was regarding PTSD, with the message being that PTSD affects more than just those who have been in wars, and that experiences like trauma in foster homes can cause PTSD. The second student shared that his group chose the topic of anxiety because one in three adolescents have anxiety. His group wanted to show through their video that those who have anxiety are not alone, and that help can come in many forms. Sara stated they plan to use the videos during health awareness week next school year.

The students stated that one of the great things about the program is being able to network with the guest speakers from the health community that come to the class, and that even if a health career is not their path, the experience with the community members is valuable.

Susi shared that the program was funded through a grant from the Workforce Development Board which ended on March 30. The schools are committed to sustain the programs for one year, and will continue beyond that time if enrollment is sufficient.

## 9.1 Superintendent's Report

Dr. Hartley mentioned that the Glen Paul graduation was once again a great ceremony. This year, students from the ArMac orchestra played. After the event, an email was received from the conductor saying the students that played were so moved by the event that they felt it was the most impactful graduation they'd been to, including their own.

Dr. Hartley mentioned that community school graduation was later that day, with 52 graduating.

Dr. Hartley recognized and thanked this year's retirees: Maureen Yost with 23 years of service, Yvonne Thompson with 26 years of service, Peggy Jansen with 11 years of service, and Laurie Wallace with 18 years of service.

Dr. Hartley stated that the local legislative action events are showing results. The Senate and Assembly are pushing forward to bring all SELPAs up to 50% range. For our SELPA alone, bring them up to the 50% level equates to 1.4 million dollars.

Dr. Hartley shared that Maple Creek School District's enrollment is down such that a waiver from the state was necessary to avoid lapsation. He went to their board meeting to talk to the community about why the school is important to them and subsequently wrote a letter of support for the waiver, which was approved by the state. A letter was received from the district thanking him for his support. The district superintendent took students to the State Capitol for the hearing on the waiver.

Dr. Hartley mentioned a workshop held recently at the Sequoia Conference Center, Counting on Community, which was a partnership between multiple county agencies. There were great learnings around Adverse Childhood Experiences (ACEs) presented, with one speaker sharing concepts around epigenetic heritability of trauma.

### 9.2 Board Retreat Date and Agenda

The board wishes to hold their retreat prior to the August 14 meeting. They enjoyed last year's retreat at the HydroFarms and would like to explore another HCOE site. Glen Paul and Eureka Community School sites were mentioned. Dr. Hartley stated he would like to connect the retreat with work around Multi-tiered System of Support (MTSS).
