(6.1) Review and Approve Bylaws for the Humboldt County Committee on School District Organization

Davies-Hughes reminded the Committee of the presentation provided by School and College Legal Services and the introduction of bylaws during the November 29, 2022 meeting. The Committee asked that the approval of bylaws be brought back to the Committee during a subsequent meeting. The consensus of the Committee was that bylaws would be a benefit for self-governance. It was clarified that the Committee had no existing bylaws.

It was moved/seconded by Fisch/Woods to approve the proposed bylaws. Ayes 6, noes 0, absent 3, abstain 0. Motion carried.

(6.2) Possible Approval of Reduction of Number of Trustees for Big Lagoon Union Elementary School District

Davies-Hughes expressed gratitude to all Committee members for their service. Davies-Hughes shared background information with the Committee regarding the Big Lagoon Union Elementary School District and the reasons behind the proposed reduction in board membership, including the June 2022 resignation of all board members and superintendent and the current composition of the Board. Big Lagoon Interim Principal/Superintendent Rosie Slentz explained the waiver of election approval process to the Committee and answered Committee guestions.

It was moved/seconded by Fisch/Rebholtz to approve the reduction of trustees from five to three for the Big Lagoon Union Elementary School District, contingent on approval of the waiver of election by the State Board of Education. Ayes 6, noes 0, absent 3, abstain 0. Motion carried.
