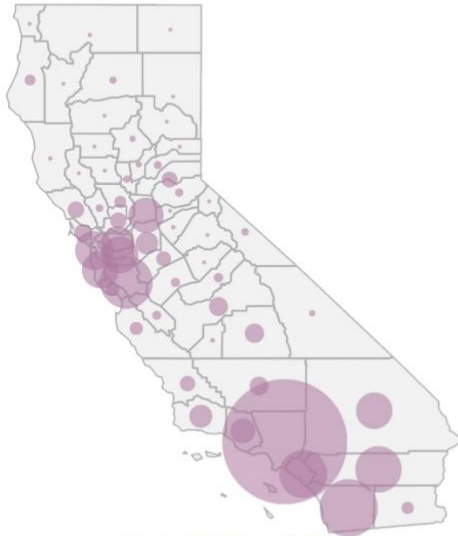

April 8, 2020 – No New Positive Cases Today

- Total number of positive cases: 50
- Total number of hospitalizations: 3

Total number of people tested by Public Health Laboratory: 688

Total number of people tested by all other sources: 555

The Public Health Laboratory currently has a capacity of approximately 450 tests and can process about 55 samples a day with an approximate turnaround time of 48 to 72 hours.

Data available to date indicates the following means of transmission for all Humboldt County cases: Of the 50 cases:

- Contact to a Known Case: 23
- Travel-Acquired: 20
- Community Transmission: 7
- Under Investigation: 3
