## NATIONAL:

- Total cases: 957,875 (+92,290) (4,999 probable)
- Total deaths: 53,922 (+5,106) (6,142 probable)

\*\*Total jurisdictions includes 50 states, District of Columbia, Guam, the Northern Mariana Islands, Puerto Rico, and the U.S Virgin Islands.

# STATE:

As of April 26:

- 43,464 positive cases (+4,210)
- 1,755 deaths (+193)

Approximately 553,409 tests have been conducted.


