NEWS ALERTS AND UPDATES – June 2, 2020

NATIONAL:

- Total cases 1,802,470 (+14,790)
- Total deaths: 105,157 (+761)

31 jurisdictions report more than 10,000 cases of COVID-19

STATE:

- 115,310positive cases (+2,304 +2%)
- 4,286deaths (+35 +0.8%)

Approximately 2,071,591 tests have been conducted.

LOCAL:

June 2, 2020 - One New Case Confirmed Today; Fourth Death

The individual who died was an elderly resident of Alder Bay Assisted Living and was diagnosed with COVID-19 early in the facility's outbreak. Another round of testing was completed today at the facility, and there are no new positive cases in staff or residents. Ten days have passed since the last new positive case at Alder Bay. <u>Read more</u>

The following information is based on the most recent data available for all confirmed cases:

- Contact to a Known Case: 59 (no chg)
- Travel-Acquired: 24 (no chg)
- Community Transmission: 17 (no chg)
- Under Investigation: 3 (+1)

Daily COVID-19 case report for June 2

- Total number of positive cases: 103 (+1)
- Total number of recovered cases: 82 (+6)
- Total number of hospitalizations: 13 (no chg)
- Total number of deaths: 4 (+1)

Number of tests run since last report

- Public Health Laboratory: 124
- OptumServe public testing site: 115

Total tests run to date

- Public Health Laboratory: 3,163
- OptumServe public testing site: 2,608

Public Health Laboratory testing Information

- Supply capacity: Approximately 1,900 tests
- Testing capacity: 65 samples per day
- Turnaround time: 48 to 72 hours

** In an effort to become more precise with data reporting, some changes have to be made to daily lab result numbers. Over time, information from commercial laboratories and other sources has become increasingly unreliable as more testing devices and methodologies have come online. Going forward, the Joint Information Center will report only data from the Humboldt County Public Health Laboratory and the OptumServe public test
