NEWS ALERTS AND UPDATES - June 16, 2020

NATIONAL:

- Total cases 2,104,346 (+18,577)
- Total deaths: 116,140 (+496)

*37 jurisdictions report more than 10,000 cases of COVID-19

STATE:

- 153,560 positive cases (+2,108; 1.4%)
- 5,121 deaths (+32; 0.6%)

*2,937,755 tests have been conducted.

June 16, 2020 – One New Cases Confirmed Today

One additional case of COVID-19 was reported today, bringing to 107 the total number of county residents who have tested positive for the virus. This new case was determined to have been acquired through community transmission.

The following information is based on the most recent data available for all confirmed cases:

- Contact to a Known Case: 61 (no chg)
- Travel-Acquired: 24 (no chg)
- Community Transmission: 22 (+1)
- Under Investigation: 0 (no chg)

- Total number of positive cases: 107 (+1)
- Total number of recovered cases: 1001 (+1)
- Total number of hospitalizations: 13 (no chg)
- Total number of deaths: 4 (no chg)

Total tests run to date

- Public Health Laboratory: 3,771
- OptumServe public testing site: 3,524
