NATIONAL:

- Total cases 3,882,167 (+63,028)
- Total deaths: 141,677 (+1,047)

STATE:

- Positive cases: 413,576 (+12,807)
- Deaths: 7,870 (+115)

6,664,419 tests have been conducted in California. Current 14-day Positivity Rate in California: 7.4%

The 12,807 new cases reported today mark a new record high for California.

Newsom gives update on state efforts to secure supply of PPE

Governor Gavin Newsom held his COVID update press conference Wednesday from a warehouse in Sacramento where Personal Protective Equipment (PPE), explaining in detail the state's efforts to secure a reliable supply of masks and other supplies. ICYMI: State guidance for safe reopening of schools

July 21, 2020 – Five New Cases Reported Today

Humboldt County's count of confirmed COVID-19 cases now stands at exactly 200 cases, after five additional cases were reported today. The county alert level remains at Level 2. View <u>the</u> <u>County Dashboard</u> for details on what the alert level means. One bit of good news is that the County 7-day average Positivity Rate dropped from 4.5% to 3.9%.

Dr. Frankovich called reaching the dubious milestone unfortunate but foreseeable, given that Humboldt County was the first rural county in the nation to confirm a case, back on Feb. 20. She reminded the public to continue to be vigilant in doing what we can to slow the spread – wear masks, wash hands, and maintain social distance from those outside our own households.
