8.1 Superintendent's Report

- First Week Enrollment Humboldt County Dr. Hartley explained the projected enrollment is what districts based their budgets on last spring. Overall, first week enrollment came in higher, but some districts individually came in lower. Our fiscal office will follow up with those districts. Charters overall were somewhat under their projections, but these numbers can change as the school year continues and more students enroll. Countywide enrollment dropped by 69, remaining fairly stable.
- Facilities & Modernization Dr. Hartley shared that he will be interviewing architects for modernization. The county was eligible for state funds for modernization which we applied for.

9.0 HUMBOLDT COUNTY TEACHER OF THE YEAR RECOGNITION (4:15 p.m.)

Dr. Hartley shared that this year, two people were chosen as the Humboldt County Teacher of the Year – Tim Olson and Johanna Mauro, and that Johanna has been asked to go on to the State level. Dr. Harley and President Eckenrode recognized both with awards.
