ISSUE:

Update on *Williams* Settlement 2020-2021 review process and COVID-19 impact on the State of Humboldt Schools Annual Report

BACKGROUND:

In accordance with the *Williams* Settlement legislation, California Education Code section 1240 requirement and AB 1761, the Humboldt County Office of Education must annually visit schools in deciles 1 to 3 that were identified using the 2012 Base Academic Performance Index (API) and report observations to the Humboldt County Board of Education. In addition, the Humboldt County Office of Education collects data on the numbers of Uniform Complaints for all school districts in San Diego County.

SB 820 signed into law on September 18, 2020, provided for flexibility with the *Williams* legislation for the 2020-21 school year due to the COVID-19 pandemic.

Lori Breyer, Coordinator for the *Williams* Settlement, will report on the updates to Humboldt County Office of Education's oversight responsibilities and will be prepared to interact with the Board regarding the current status of the State of Humboldt Schools *Williams* Settlement Annual Report.
